Jose A. Naig, Acting District Collector, together with the men and women of Collection District VI, attended the Orientation to Government Employees (Communist Terrorist Group Problem) on Monday, October 14, 2019 at 8:30 A.M. at the Assessment Division, Customs House Building, Muelle Loney Street, Iloilo City conducted by National Intelligence Coordinating Council (NICA) Region VI.
