October 26-31, 2018

Dr. Wivina B. Pumatong, CESE District Collector together with outgoing Commissioner Isidro S. Lapeña, PhD., Incoming Commissioner Rey Leonardo B. Guerrero, Deputy Commissioners, District Collectors and Service Directors attended the BOC Command Conference and Turn-Over Ceremony on Wednesday October 31, 2018 at Port of Manila.

For this week, the entire district has a total of 12 entries filed; export and formal entries.

At the main office, two (2) formal entries were filed and two (2) are still in progress. Five (5) Export was filed and completed.

For the Subport of Pulupandan, five (5) formal entries were filed; one (1) entry was completed and four (4) are still in progress.
