*August 9 – 15, 2019*

Jose A. Naig, Acting District Collector, had a Video Conference together with Commissioner Rey Leonardo B. Guerrero, Deputy Commissioner, District Collectors and Service Collectors on Monday, August 12, 2019 at 8:00 A.M. to 11:00 A.M.

Jose A. Naig, Acting District Collector, attended the 3<sup>rd</sup> Coordination Meeting by the Regional Inter-Agency Committee on Anti-Illegal Drugs Coordinating Group at the Penthouse, Iloilo City Hall, Iloilo City on August 16, 2019 at 1:00 P.M.

For this week, the entire district has a total of Twenty Two (22) entries filed, export and formal entries.

At the main office, Five (5) formal entries were filed; One (1) entry was in progress and Four (4) entries were completed; One (1) Informal entry was filed and completed; and Six (6) Export entries were filed and completed.
