## NARRATIVE REPORT

June 14-20, 2019

Coll. Gerardo A. Campo, Officer-in-Charge, Port of Iloilo, attended the launching of the Bureau of Customs' Computer System Modernization Projects with a Theme "The Improved BOC: Seamless and Simplified", on Monday June 17, 2019 from 2:00 P.M. onwards at the Ball Room 3, 2<sup>nd</sup> Floor, Rizal Park Hotel, South Road Drive, T.M. Kalaw Ext., Ermita, Manila.

Coll. Gerardo A. Campo, Officer-in-Charge, Port of Iloilo, together with Atty. Ramon Rory Antiojo, Port Operations Division, Port of Iloilo had a courtesy call to Commissioner Rey Leonardo B. Guerrero, on June 18, 2019 at the Office of the Commissioner, Bureau of Customs, Port Area, Manila.

Coll. Gerardo A. Campo, Officer-in-Charge, Port of Iloilo, attended a meeting and ocular inspection together with Atty. Ramon Rory Antiojo-OIC, Port Operations Division, Port of Iloilo and Representatives from Port Operations Service (POS), AOCG, Bureau of Customs, Manila at La Filipina Uygongco Corporation Wharf, Quarantine Road, Brgy. Progreso, Lapaz, Iloilo City on June 20, 2019 relative to their application for accreditation as Authorized Customs Facility.

For this week, the entire district has a total of Thirty Two (32) entries filed; export and formal entries.

At the main office, Eight (8) formal entries were filed; Four (4) entries were in progress and Four (4) entries were completed; Three (3) Informal entries were filed and were completed; and Three (3) Export entries were filed and completed.

For the Subport of Pulupandan, Thirteen (13) formal entries were filed; Four (4) entries were in progress and Nine (9) entries were completed.

There are no reports for balikbayan boxes, auctions, alert orders and apprehensions.
