Coll. Gerardo A. Campo, Officer-in-Charge, Port of Iloilo, attended the Collectors' Conference together with Commissioner Rey Leonardo B. Guerrero, Deputy Commissioner, District Collectors and Service Collectors on Monday July 1, 2019 at 8:00 A/M/ to 12:00 P.M. at Bai Hotel, Ouano Avenue Corner C.D. Seno St., South Special Economic Administrative Zone, Mandaue City, Cebu.

Coll. Gerardo A. Campo, Officer-in-Charge, Port of Iloilo, had a meeting/courtesy call with Philippine Drug Enforcement Agency Officers at the Collectors' Office, Customs House Building, Muelle Loney St., Iloilo City at 9;00 A.M.

For this week, the entire district has a total of Twenty Seven (27) entries filed; export and formal entries.

At the main office, Six (6) formal entries were filed; Five (5) entries were in progress and one (1) is completed; Four (4) Informal entries and were completed; and Six (6) Export entries were filed and were completed.

For the Subport of Pulupandan, Ten (10) formal entries were filed; Four (4) entries were in progress and Six (6) entries were completed; and One (1) Export entry was filed and completed.
