NOTICE AND DECLARATION OF ABANDONMENT

WHEREAS, on 29 March 2021, the Law Division, this Port received the Memorandum dated 24 March 2021 of Mr. Richard S. Rebong, DPA, Chief, Baggage Assistance Division, thru Atty. Ma. Lourdes V. Mangaoang, CSEE, Deputy Collector for Passenger Service, recommending the institution of abandonment proceedings against all the overstaying/unclaimed pieces of baggage which reportedly remained unclaimed at the Interline Baggage Room at the NAIA Terminal 1, 2 & 3;

WHEREAS, records show that despite notices as attested in the herewith attached Certification dated 29 March 2021, a total of One-Hundred Twenty-Six (126) pieces of baggage at the Interline Baggage Room at the NAIA Terminal 1, 2 & 3 which reportedly remained unclaimed despite notice, the details of which are as follows:

WHEREAS, Section 10.4 of Customs Administrative Order (CAO) No. 1-2017 provides: **Section 10. Treatment of Interline Baggage.**

10.4. All Interline Baggage, which remain unclaimed after thirty (30) days from arrival shall be subject to abandonment proceedings.

WHEREFORE, premises considered, it is hereby ordered and decreed that the above-described pieces of baggage be, as it is hereby ordered abandoned in favor of the government pursuant to Section 10.4 of CAO 1-2017, the same to be turned over to the Auction and Cargo Disposal Division, this Port, for inventory, custody and safekeeping pending the final disposition thereof in the manner provided for by law.

Let copies of this Notice and Declaration of Abandonment be referred to the Baggage Assistance Division, this Port, for service to all parties and offices concerned, and copies thereof be posted on the Bulletin Boards of the Office of the District Collector; Law Division; Office of the Baggage Assistance Division, this Port; and electronic posting in the BOC website, thru the Public Information and Assistance Division (PIAD) pursuant to existing Customs laws, rules and regulations.
