RESOLUTION NO. 2018 – 11**

WHEREAS, the Bureau of Customs – Bids and Awards Committee (BOC-BAC) conducted a public bidding for the project "**Supply and Delivery of Twenty Four (24) Brand New Units of Binoculars**", with a total Approved Budget for the Contract (ABC) of One Million Two Hundred Thousand Pesos (P1,200,000.00);

WHEREAS, on 19 June 2018, the Invitation to Bid was published in the Philippine Star and posted in PhilGEPS, in the BOC website, and in conspicuous places at the premises of the BOC;

WHEREAS, in response to said invitation, only Clean World Trading and Supplies, Inc. attended the pre-bid conference on 26 June 2018;

WHEREAS, during the scheduled submission and opening of bids on 10 July 2018, Contactpoint, Inc. and Clean World Trading and Supplies, Inc. submitted their respective bids;

WHEREAS, Clean World Trading and Supplies, Inc. passed the eligibility and technical documents screening. On the other hand, the bid of Contactpoint Inc. was declared as "failed" for its failure to sign/initial all the pages of their submitted Bid Form in accordance with Section II. Instructions to Bidders, ITB Clause 19.4 of the Bidding Documents;

WHEREAS, the financial bid offered by Clean World Trading and Supplies, Inc. is One Million Two Hundred Thousand Pesos (P1,200,000.00);

WHEREAS, the bid of Clean World Trading and Supplies, Inc. was declared as the single calculated bid and was subjected to the post-qualification process;

WHEREAS, the Technical Working Group conducted the post-qualification and verified, validated and ascertained that Clean World Trading and Supplies, Inc. has complied with all the eligibility and technical requirements;

WHEREAS, after evaluation and deliberation, the BOC-BAC declared Clean World Trading and Supplies, Inc. as the bidder with the Single Calculated Responsive Bid;

NOW, THEREFORE, the BOC-BAC **RESOLVED**, as it is hereby **RESOLVED** to recommend to the Commissioner of Customs to:

- 1) Award the contract for the "Supply and Delivery of Twenty Four (24) Brand New Units of Binoculars" to Clean World Trading and Supplies, Inc.;
- 2) Approve the Notice of Award; and
- 3) Approve the Contract and the Notice to Proceed (to be issued after the posting by the Service Provider of the Performance Security).

CONTRACT FOR THE CATERING SERVICES FOR SUPPLY AND DELIVERY OF TWENTY FOUR (24) BRAND NEW UNITS OF BINOCULARS

THIS CONTRACT made and entered into by and between the following:

BUREAU OF CUSTOMS, a government agency created by virtue of the law of the Philippines, with principal office located at Gate 3, South Harbor, Port Area, Manila, represented herein by its Commissioner, **ISIDRO S. LAPENA, PhD, CSEE** (hereinafter called the "BOC");

-and-

CLEAN WORLD TRADING AND SUPPLIES, INC., a corporation duly organized and existing under the laws of the Philippines, with principal office located at 117 Guadalupe St., Morning Breeze Subd., Brgy. 83, Caloocan City, represented herein by its Senior Account Manager, **EDSEL D. GOMEZ** (hereinafter called the "Service Provider");

WITNESSETH:

WHEREAS, the BOC conducted a public bidding for the project "Supply and Delivery of Twenty Four (24) Brand New Units of Binoculars" and the bid of the Service Provider in the total amount of One Million Two Hundred Thousand Pesos (P1,200,000.00) was determined to be the Single Calculated Responsive Bid;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby mutually stipulate and agree as follows:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the General and Special Conditions of Contract referred to in Annex "D" and "E", respectively.
2. The following documents shall form and be read and construed as part of this Contract:

Annex "A" The Service Provider's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;

"B" Schedule of Requirements;

"C" Technical Specifications;

"D" General Conditions of Contract;

"E" Special Conditions of Contract;

"F" Notice of Award; and

"G" Performance Security.


3. In consideration of the payments to be made by the BOC to the Service Provider, the Service Provider hereby covenants with the BOC to provide the Goods and Services and to remedy defects therein in conformity with the provisions of the Contract.
4. The BOC hereby covenants to pay the Service Provider, in consideration of the provision of the Goods and Services and the remedying of defects herein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.
