# **CONTRACT FOR OPERATIONS MANAGEMENT PLATFORM – ONLINE ALERTS MANAGEMENT SYSTEM (PRODUCTION)**

THIS CONTRACT made and entered into by and between the following:

**BUREAU OF CUSTOMS**, a government agency created by virtue of the laws of the Philippines, with principal office located at Gate 3, South Harbor, Port Area, Manila, represented herein by Commissioner **ALBERTO D. LINA** (hereinafter called the "BOC");

-and-

**BEACON SOLUTIONS, INC.**, a corporation organized and existing under the laws of the Philippines, with principal office located at Unit 314 Corporate 101 Bldg., #101 Mother Ignacia Ave., South Triangle 4, Quezon City, represented herein by its President, **MARIA FE N. FERRIOLS** (hereinafter called the "Service Provider");

## **WITNESSETH:**
