

BIDS AND AWARDS COMMITTEE RESOLUTION NO. 2016 – 59

WHEREAS, the Bureau of Customs – Bids and Awards Committee (BOC-BAC) conducted a public bidding for the project **Procurement for the Supply, Delivery and Installation of Air-conditioning Equipment**, with a total Approved Budget for the Contract (ABC) of Seven Million Nine Hundred Thirty Five Thousand Pesos (\$\frac{12}{27}\$,935,000.00);

WHEREAS, on 08 November 2016, the Invitation to Bid was posted in PhilGEPS, in the BOC website, and in conspicuous places at the premises of the BOC;

WHEREAS, in response to said invitation, Margarita Macarana, CAC, Totaline Air System, Inc., TradeMaster Resources Corp., Thermozone Philippines Corp. and K Servico, attended the pre-bid conference on 15 November 2016;

WHEREAS, during the scheduled submission and opening of bids on 01 December 2016, only Thermozone Philippines Corp. submitted its bid but was declared "FAILED" for its failure to attach a photocopy of their PhilGEPS Certificate in Copy 1 and Copy 2 of their bid as required under Section III. Bid Data Sheet, ITB Clause 20.3, and for failure to meet the requirements on the submission of the Single Largest Completed Contract as required under Section III. Bid Data Sheet, ITB Clause 5.4 of the Bidding Documents;

WHEREAS, the BOC-BAC, in its Resolution No. 2016-46 recommended to the Commissioner the declaration of failure of bidding in accordance with Section 35.1 (c) of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 08 December 2016, the BOC-BAC then conducted a second public bidding for the same project where the Invitation to Bid was posted in PhilGEPS, in the BOC website and in conspicuous places at the premises of the BOC;

WHEREAS, in response to said invitation, TradeMaster Resources Corp. and Thermozone Philippines Corp. attended the pre-bid conference on 15 December 2016;

WHEREAS, during the scheduled submission and opening of bids on 27 December 2016, only TradeMaster Resources Corp. submitted its bid and passed the eligibility and technical documents screening;

WHEREAS, the bid offered by TradeMaster Resources Corp. is Six Million Nine Hundred Eighty, Five Thousand Pesos (\$\frac{1}{2}\$6,985,000.00);

WHEREAS, the bid of TradeMaster Resources Corp. was declared as the single calculated bid and was subjected to the post-qualification process;

WHEREAS, the Technical Working Group conducted the post-qualification and verified, validated and ascertained that TradeMaster Resources Corp. have complied with all the eligibility and technical requirements;

WHEREAS, after evaluation and deliberation, the BOC-BAC declared TradeMaster Resources Corp. as the bidder with the Single Calculated Responsive Bid;

CONTRACT FOR THE PROCUREMENT FOR THE SUPPLY, DELIVERY AND INSTALLATION OF AIR-CONDITIONING EQUIPMENT

THIS CONTRACT made and entered into by and between the following:

BUREAU OF CUSTOMS, a government agency created by virtue of the law of the Philippines, with principal office located at Gate 3, South Harbor, Port Area, Manila, represented herein by Commissioner **NICANOR E. FAELDON** (hereinafter called the "BOC");

-and-

TRADEMASTER RESOURCES CORP., a corporation duly organized and existing under the laws of the Philippines, with principal office located at Lot E Impex Compound, Alabang, Zapote Road, Las Pinas City, represented herein by its Sales Manager, **MELVIN R. ZABALA** (hereinafter called the "Service Provider");

WITNESSETH:

WHEREAS, the BOC conducted a public bidding for the Procurement for the Supply, Delivery and Installation of Air-conditioning Equipment and the bid of the Service Provider in the total amount of Six Million Nine Hundred Eighty Five Thousand Pesos (\$\frac{1}{2}\$6,985,000.00) was determined to be the Single Calculated Responsive Bid;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby mutually stipulate and agree as follows:

- 1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the General and Special Conditions of Contract referred to in Annex D and E, respectively.
- 2. The following documents shall form and be read and construed as part of this Contract:

Annex A - Bid Form;

B - Schedule of Requirements;

C - Technical Specifications;

D - General Conditions of Contract;

E - Special Conditions of Contract;

F - Notice of Award; and

G - Performance Security.

- 3. In consideration of the payments to be made by the BOC to the Service Provider, the Service Provider hereby covenants with the BOC to provide the Goods and Services and to remedy defects therein in conformity with the provisions of the Contract.
- 4. The BOC hereby covenants to pay the Service Provider, in consideration of the provision of the Goods and Services and the remedying of defects herein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.
