THIS CONTRACT made and entered into by and between the following:

BUREAU OF CUSTOMS, a government agency created by virtue of the law of the Philippines, with principal office located at Gate 3, South Harbor, Port Area, Manila, represented herein by Commissioner **NICANOR E. FAELDON** (hereinafter called the "BOC");

-and-

LBP SERVICE CORPORATION, a corporation duly organized and existing under the laws of the Philippines, with principal office located at 21st Floor, Building 358, Petron Mega Plaza, Sen. Gil J. Puyat Ave., Makati City, represented herein by its Senior Vice-President, **JOSEPH V. ANGELES** (hereinafter called the "Service Provider");

WITNESSETH:

WHEREAS, the BOC conducted a public bidding for the Provision of Janitorial Manpower Services and the bid of the Service Provider in the total amount of Twenty Two Million Five Hundred Eighty Two Thousand Eight Hundred Twelve Pesos (Php22,582,812.00), inclusive of VAT, and was determined to be the Lowest Calculated Responsive Bid;

- 3. In consideration of the payments to be made by the BOC to the Service Provider, the Service Provider hereby covenants with the BOC to provide the Goods and Services and to remedy defects therein in conformity with the provisions of the Contract.

The BOC hereby covenants to pay the Service Provider, in consideration of the provision of the Goods and Services and the remedying of defects herein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.
