**BIDS AND AWARDS COMMITTEE
RESOLUTION NO. 2016 – 53**

WHEREAS, the Bureau of Customs – Bids and Awards Committee (BOC-BAC) conducted a public bidding for the project Supply, Delivery, Installation, Configuration, Testing and Commissioning of IP-Based CCTV System for the Bureau of Customs (BOC), with a total Approved Budget for the Contract (ABC) of Seventy Million Nine Hundred Thousand Pesos (₱70,900,000.00);

WHEREAS, on 24 November 2016, the Invitation to Bid was published in the Philippine Star and posted in the PhilGEPS, in the BOC website, and in conspicuous places at the premises of the BOC;

WHEREAS, in response to said invitation, PLDT & NETPA, ACEL Enterprises, Advanced Security & Safety Solutions Inc., Pronet Systems, ITBS Information Technology Business Corporation, One Touch Communications and Faire Technologies Inc., attended the pre-bid conference on 01 December 2016;

WHEREAS, during the scheduled submission and opening of bids on 13 December 2016, ITBS Information Technology Business Corporation and Faire Technologies Inc. submitted their respective bids and passed the eligibility and technical documents screening;

WHEREAS, the financial bid offered are summarized as follows:

1. ITBS Information Technology Business Corporation: Sixty Nine Million Three Hundred Eighty Two Thousand Pesos (₱69,382,000.00); and
2. Faire Technologies Inc.: Sixty Nine Million Four Hundred Fifty Thousand Pesos (₱69,450,000.00).

WHEREAS, the bid of ITBS Information Technology Business Corporation was declared as the lowest calculated bid and was subjected to the post-qualification process;

WHEREAS, the Technical Working Group conducted the post-qualification and verified, validated and ascertained that ITBS Information Technology Business Corporation have complied with all the eligibility and technical requirements;

WHEREAS, after evaluation and deliberation, the BOC-BAC declared ITBS Information Technology Business Corporation as the bidder with the Lowest Calculated Responsive Bid;

THIS CONTRACT made and entered into by and between the following:

BUREAU OF CUSTOMS, a government agency created by virtue of the law of the Philippines, with principal office located at Gate 3, South Harbor, Port Area, Manila, represented herein by Commissioner **NICANOR E. FAELDON** (hereinafter called the "BOC");

ITBS INFORMATION TECHNOLOGY BUSINESS SOLUTIONS CORPORATION, a corporation duly organized and existing under the laws of the Philippines, with principal office located at 7a AEC Commercial Complex, Greenville Subd., O.G. Road, San Fernando City, Pampanga, represented herein by its Project Manager, **GILLIAN NICOLE CLEMENTE ALAMANI** (hereinafter called the "Service Provider");

WITNESSETH:

WHEREAS, the BOC conducted a public bidding for the Supply, Delivery, Installation, Configuration, Testing and Commissioning of IP-Based CCTV System for the Bureau of Customs (BOC) and the bid of the Service Provider in the total amount of Sixty Nine Million Three Hundred Eighty Two Thousand Pesos (₱69,382,000.00) was determined to be the Lowest Calculated Responsive Bid;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby mutually stipulate and agree as follows:

3. In consideration of the payments to be made by the BOC to the Service Provider, the Service Provider hereby covenants with the BOC to provide the Goods and Services and to remedy defects therein in conformity with the provisions of the Contract.
4. The BOC hereby covenants to pay the Service Provider, in consideration of the provision of the Goods and Services and the remedying of defects herein, the
