

4 DESCRIPTION OF GOOD

"MASTECO AUTOMATIC FIRE EXTINGUISHER"

Based on the brochure, lay-out plan, and technical information submitted, subject article is an automatic fire extinguishing system consisting of four (4) steel cylinders, interconnected in series, and charged with pressurized refrigerant HFC-125 (pentafluoroethane). Each cylinder is fitted with a glass bulb sprinkler (fire detector), brass valve, and nozzle. During operation, a significant rise in temperature detected by the glass bulbs triggers the valves to open and release the contents of the cylinders, through the nozzles, which then absorbs the heat and eventually suppresses a fire. Designed to be mounted on walls in small spaces, subject article has the following specifications:

Cylinder capacity	9 kg
Temperature detection	68°C
Cylinder gauge pressure	25 bar
Total area coverage (max.)	64.09 m ²

5 REASONS FOR CLASSIFICATION

Heading 84.24 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, fire extinguishers, whether or not charged. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this group covers extinguishers, filled or not, of the kind which use foam-producing or other charges, including simple extinguishers fitted with taps, valves, percussion caps or other opening devices.

In view thereof, subject article is classified under AHTN 2017 subheading 8424.10.90, with a Most Favoured Nation (MFN) rate of duty of 7% ad valorem and ASEAN-Korea Free Trade Area (AKFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "AK".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
