4 DESCRIPTION OF GOOD

"POPSOCKETS POPGRIP SLIDE STRETCH"

Based on the brochure, product material composition, and sample submitted, subject article is a phone grip and stand, made of thermoplastic polyurethane (TPU), polycarbonate, nylon, and adhesive. It is composed of a non-adhesive slidable base clip that fits the curved edge of phone cases measuring 70 mm to 85 mm wide, and a replaceable PopTop. Packed in a cardboard enclosure, subject article is available in various designs and colors.



5 REASONS FOR CLASSIFICATION

Heading 39.26 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers other articles of plastics and articles of other materials of headings 39.01 to 39.14. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers articles, not elsewhere specified or included, of plastics (as defined in Note 1 to the Chapter) or of other materials of headings 39.01 to 39.14. They include, among others, various other articles such as fasteners for handbags, corners for suit-cases, suspension hooks, protective cups and glides for placing under furniture, handles (of tools, knives, forks, etc.), beads, watch "glasses", figures and letters, luggage label-holders.

In view thereof, subject article is classified under AHTN 2017 subheading 3926.90.99B, with a Most Favoured Nation (MFN) rate of duty of 15% ad valorem and ASEAN-China Free Trade Area (ACFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "E".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
