

#### 4 DESCRIPTION OF GOOD

### "NINOL® 96-SL"

Based on the safety data sheet, product specifications, composition statement, and photographs of packaging and label submitted, subject article is lauramide DEA (lauric diethanolamide; CAS No. 120-40-1), with residual unreacted diethanolamine (raw material). It is in the form of a white paste and is used as a maximum foam enhancer and viscosity booster. Available in 55-gallon drums, subject article is used as a raw material in the manufacture of shampoos, bubble baths, bath soaps, and detergents, among others. It has a carboxyamide structure as follows:

#### 5 REASONS FOR CLASSIFICATION

Note 1(a) to Chapter 29 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 states that except where the context otherwise requires, the headings of this Chapter apply only to separate chemically defined organic compounds, whether or not containing impurities.

Heading 29.24 of the AHTN 2017 covers, among others, carboxyamide-function compounds. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers amide derivatives of carboxylic acids and of carbonic acid (but not amide derivatives of other inorganic acids of heading 29.29).

In view thereof, subject article is classified under AHTN 2017 subheading 2924.19.90, with a Most Favoured Nation (MFN) rate of duty of 1% ad valorem.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
