



#### 4 DESCRIPTION OF GOOD

#### "CONDALAB PTC AGAR (INDUSTRIAL AGAR)"

Based on the product safety information sheet and product data sheet submitted, subject article is a 100% agar in the form of a fine beige powder. It is extracted from several species of red algae, mainly the *Gelidium*, *Gracilaria*, and *Pterocladia* species. Packed in 500-g plastic containers, subject article is used as a gelling agent for culture media.

#### 5 REASONS FOR CLASSIFICATION

Heading 13.02 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, agar-agar and other mucilages and thickeners, whether or not modified, derived from vegetable products. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers mucilages and thickeners, derived from vegetable products, which swell in cold water and dissolve in hot, forming a homogeneous, gelatinous and generally tasteless mass on cooling. They are chiefly used as alternatives to gelatin in the preparation of food, in the manufacture of textile or paper dressings, to clarify certain liquids, for bacterial culture, in pharmacy and in the manufacture of cosmetics. They may be modified by chemical treatment (for example, esterified, etherified, treated with borax, acids or alkalis). The most important is, among others, agar-agar (or agar) obtained by extraction from certain marine algae found mainly in the Indian and Pacific Oceans, and usually presented in the form of dried fibres, flakes, powder or in a gelatinous form obtained by treatment with acids. It is commercially known as "gelose" and also as Japanese vegetable gelatin (or moss) or *Alga spinosa*.

In view thereof, subject article is classified under AHTN 2017 subheading 1302.31.00, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

### "APPLICATION CONTROLLER, MODEL: DAC-1146"

Based on the brochure and functional block diagram submitted, subject article is a fully programmable application controller that communicates on an RS-485 Local Area Network (LAN) using the BACnet Master-Slave Token Passing (MS/TP) protocol. It is designed for building automation system (BAS) and consists of, among others, switches and jumpers for device addressing, ports for communication with other application controllers and field modules, and network accessible input and output ports for the remote accessing or control of digital and analog input or output signals. Capable of creating or modifying building automation programs in a BAS where medium input-output requirements are needed to control various equipment, subject article has the following specifications:

The pertinent Harmonized System (HS) Explanatory Notes (EN) state that the heading also covers, among others, "programmable controllers" which are digital apparatus using a programmable memory for the storage of instructions for implementing specific functions such as logic, sequencing, timing, counting and arithmetic, to control, through digital or analog input/output modules, various types of machines.

In view thereof, subject article is classified under AHTN 2017 subheading 8537.10.99C, with a Most Favoured Nation (MFN) rate of duty of 5% ad valorem.

Its standard accessories include an irrigation tube holder, sliding keyboard tray, scope pole kit, and LCD monitor arm. Designed to enhance the observation of various medical specialties or surgeries, subject article has the following specifications:

### 4 DESCRIPTION OF GOOD

#### "AntioxFeed™"

Based on the ingredient list, material safety data sheet, manufacturing process flowchart, and product information submitted, subject article is a feed antioxidant in the form of a yellow to dark brown powder. It consists of butylated hydroxytoluene (BHT), propylgallate, tea polyphenol (antioxidants), and silica (carrier). It removes free radicals and resolve peroxide to prevent oxidation of vitamins, carotenoids, fats, and lipids in feeds. Packed in 25-kg bags, subject article is added at a rate of 125 to 1000 grams per ton of compound, premix, or aquatic feed, to maintain freshness, palatability, and nutritional value of feeds, improve feed quality, and extend shelf-life.

# 5 REASONS FOR CLASSIFICATION

Heading 38.24 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, chemical products and preparations of the chemical or allied industries (including those consisting of mixtures of natural products), not elsewhere specified or included. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that the chemical or other preparations are either mixtures (of which emulsions and dispersions are special forms) or occasionally solutions. Aqueous solutions of the chemical products of Chapter 28 or 29 remain classified within those Chapters, but solutions of these products in solvents other than water are, apart from a few exceptions, excluded therefrom and accordingly fall to be treated as preparations of this heading. The preparations classified here may be either wholly or partly of chemical products (this is generally the case) or wholly of natural constituents.

In view thereof, subject article is classified under AHTN 2017 subheading 3824.99.99, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem and ASEAN-China Free Trade Area (ACFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "E".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

#### 4 DESCRIPTION OF GOOD

#### "CORYNA® DF"

Based on the product information sheet, duly certified product composition, and safety data sheet submitted, subject article is an aqueous solution of carbendazim, octhilinone (ISO), and xanthan gum, in the form of a white to light beige creamy liquid. Packed in 20-kg plastic pails, subject article is used as a fungicide and algicide in water-based systems and water-based paint formulations added at a dosage of 0.10 to 2% to protect dry film against the growth of fungi and algae.

#### REASONS FOR CLASSIFICATION

Heading 38.08 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers insecticides, rodenticides, fungicides, herbicides, anti-sprouting products and plant-growth regulators, disinfectants and similar products, put up in forms or packings for retail sale or as preparations or articles (for example, sulphur-treated bands, wicks and candles, and fly-papers). The pertinent Harmonized System (HS) Explanatory Notes (EN) state this heading covers a range of products (other than those having the character of medicaments, including veterinary medicaments - heading 30.03 or 30.04) intended to destroy pathogenic germs, insects (mosquitoes, moths, Colorado beetles, cockroaches, etc.), mosses and moulds, weeds, rodents, wild birds, etc. These insecticides, disinfectants, herbicides, fungicides, etc., are applied by spraying, dusting, sprinkling, coating, impregnating, etc., or may necessitate combustion. They achieve their results by nerve-poisoning, by stomach-poisoning, by asphyxiation or by odour, etc. The products of heading 38.08 include, among others, fungicides. Fungicides are products which protect against the growth of fungi (e.g., preparations based on copper compounds) or which are designed to eradicate the fungi already present (e.g., preparations based on formaldehyde).

In view thereof, subject article is classified under AHTN 2017 subheading 3808.92.90, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem.

#### 4 DESCRIPTION OF GOOD

#### "GLOBATIOX 32 PREMIX SE"

Based on the certificate of composition, manufacturing process, and technical sheet submitted, subject article is an antioxidant for animal feeds in the form of a light to dark-brown, fine, free flowing powder. It consists of butylhydroxyanisol (BHA), butylhydroxytoluene (BHT), propyl gallate, citric acid, and carriers. Packed in 25-kg polypropylene plastic bags, subject article is used for the protection of poultry and swine feeds, feed premixes, and supplements from the harmful effects of oxidation of vitamins, fats, oils and other oxidizable nutrients.

#### 5 REASONS FOR CLASSIFICATION

Heading 38.24 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, chemical products and preparations of the chemical or allied industries (including those consisting of mixtures of natural products), not elsewhere specified or included. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that the chemical or other preparations are either mixtures (of which emulsions and dispersions are special forms) or occasionally solutions. Aqueous solutions of the chemical products of Chapter 28 or 29 remain classified within those Chapters, but solutions of these products in solvents other than water are, apart from a few exceptions, excluded therefrom and accordingly fall to be treated as preparations of this heading. The preparations classified here may be either wholly or partly of chemical products (this is generally the case) or wholly of natural constituents.

In view thereof, subject article is classified under AHTN 2017 subheading 3824.99.99, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem.
