



4 DESCRIPTION OF GOOD

"ALCE OUTDOOR VOLTAGE TRANSFORMER, MODEL: VH17"

Based on the brochure and test report submitted, subject article is an instrument potential transformer conforming to standard IEC-61869-3 class. It is an outdoor-type voltage transformer used with electrical measuring instruments and/or electrical protective devices. Subject article has the following specifications:

Power Handling Capacity (kVA)	0.075	
Highest Voltage for Equipment (kV)	Up to 17.5	
Rated Primary Voltage (kV)	15/√3	
Secondary Voltage (V)	100/√3 or 110/√3 or 120/√3	
Rated Frequency (Hz)	50 or 60	

5 REASONS FOR CLASSIFICATION

Heading 85.04 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers electrical transformers, static converters (for example, rectifiers) and inductors. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers, among others, electrical transformers. Electrical transformers are apparatus which, without having any moving parts, transform, by means of induction and using a preset or adjustable system, an alternating current into another alternating current of different voltage, impedance, etc. Certain transformers are designed for particular purposes, e.g., matching transformers for matching the impedance of one circuit with that of another, and instrument transformers (current or voltage transformers, combined instrument transformers) used to step down or step up voltages or currents to the level of the connected equipment, e.g., measuring instruments, electricity meters or protective relays.

In view thereof, subject article is classified under AHTN 2017 subheading 8504.31.13, with a Most Favoured Nation (MFN) rate of duty of 1% ad valorem.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
