**Date :** 31 March 2021

This is to reiterate previous memoranda issued regarding the ban on the importation of Domestic and Wild Birds and their products including Poultry Meat, Day Old Chicks, Eggs and Semen due to the outbreak of Highly Pathogenic Avian Influenza (HPAI).
