

DESCRIPTION OF GOOD

"FUXU DISPOSABLE PROTECTIVE MASK (Non-medical Use) Model: FX-FM"

Based on the certificate of compliance, test report, and pictures submitted, subject article is a protective mask in the form of accordion-pleated layers of polypropylene nonwovens with an ear loop on each side. It meets the requirements of Level III GB/T32610-2016 standard with filtration efficiency (salt medium) of more than 90%. Packed in a polybag and carton box containing 50 masks, subject article covers the mouth and nose of the wearer and is used as a physical barrier/protection against airborne particles and liquid contaminants. It is 17.5 cm long and 9.5 cm wide.





5 REASONS FOR CLASSIFICATION

Heading 63.07 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers other made up articles, including dress patterns. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers made up articles of any textile material which are not included more specifically in other headings of Section XI or elsewhere in the Nomenclature. It includes, in particular, among others, face-masks for protection against dust, odours, etc., not equipped with a replaceable filter, but consisting of several layers of nonwovens, whether or not treated with activated carbon or having a central layer of synthetic fibres.

In view thereof, subject article is classified under AHTN 2017 subheading 6307.90.90, with a Most Favoured Nation (MFN) rate of duty of 15% ad valorem and ASEAN-China Free Trade Area (ACFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "E".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

4 DESCRIPTION OF GOOD

"BORSTAR® FB1200"

Based on the product composition reported by a third-party laboratory, technical and safety data sheets, and product statement submitted, subject article is an ethylene-butene copolymer resin containing, by weight, less than 95% ethylene and more than 5% 1-butene, with added antioxidant. It is in the form of odourless natural-colour pellets having a density of 0.921 g/cm³ and a melt flow index of 0.17 g/10 minutes at 190°C/2.16 kg reference condition. Packed in 25-kg bags, subject article is used in the manufacture of industrial films, compression packagings, and heavy-duty films, among others.

5 REASONS FOR CLASSIFICATION

Note 4 to Chapter 39 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 states that the expression "copolymers" covers all polymers in which no single monomer unit contributes 95% or more by weight to the total polymer content. For the purposes of this Chapter, except where the context otherwise requires, copolymers (including co-polycondensates, co-polyaddition products, block copolymers and graft copolymers) and polymer blends are to be classified in the heading covering polymers of that comonomer unit which predominates by weight over every other single comonomer unit.

Furthermore, Note 6(b) to Chapter 39 states that in headings 39.01 to 39.14, the expression "primary forms" applies only to blocks of irregular shape, lumps, powders (including moulding powders), granules, flakes, and similar bulk forms.

Heading 39.01 of the AHTN 2017 covers polymers of ethylene, in primary forms.

In view thereof, subject article is classified under AHTN 2017 subheading 3901.40.00, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem and an ASEAN Trade In Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D"

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
