DESCRIPTION OF GOOD

"NAN® INFINIPRO® HW ONE"

Based on the product information, formula ingredient breakdown, recipe nutritional composition, product label, manufacturer's declaration, and photograph of product packaging submitted, subject article is a hypoallergenic powdered formula for infants zero (0) to six (6) months of age. It is composed of lactose, vegetable oils, protein whey concentrate, vitamins, and minerals, among others. Packed in 400-g, 700-g, and 800-g containers, subject article is to be dissolved in distilled water prior to consumption.

REASONS FOR CLASSIFICATION

Heading 21.06 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers food preparations not elsewhere specified or included. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that provided they are not covered by any other heading of the Nomenclature, this heading covers, among others, preparations for use, either directly or after processing (such as cooking, dissolving or boiling in water, milk, etc.), for human consumption.

In view thereof, subject article is classified under AHTN 2017 subheading 2106.90.89, with a Most Favoured Nation (MFN) rate of duty of 5% ad valorem.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

4 DESCRIPTION OF GOOD

"GLUGEL 0-24-22"

Based on the certificate of composition, product specifications, and product label submitted, subject article is a potassium phosphite-based fertilizer in the form of a liquid gel solution with pH of 6.5. It consists of phosphorus pentoxide (P_2O_5), potassium oxide (K_2O), boron (B), iron (Fe), manganese (Mn) chelated by ethylenediaminetetraacetic acid (EDTA), and zinc (Zn) chelated by EDTA. Packed in 1-L, 5-L, and 20-L containers, subject article is specifically designed for the cultivation of bananas and cocoa. It is formulated to stimulate their growth and to help them cope with adverse conditions, such as stress caused by drought, root asphyxiation, insect attack or diseases.

5 REASONS FOR CLASSIFICATION

Heading 31.05 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, mineral or chemical fertilisers containing two or three of the fertilising elements nitrogen, phosphorus and potassium. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers, among others, all other fertilisers (other than separate chemically defined compounds), for example, mixtures of fertilizing substances (i.e., those containing nitrogen, phosphorus or potassium) with non-fertilising substances, e.g. sulphur. Many of those containing nitrogen or phosphorus are classified in heading 31.02 or 31.03 but the others are classified in this

In view thereof, subject article is classified under AHTN 2017 subheading 3105.60.00, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
