

# "CYNPOL® LL0119H"

Based on the product composition reported by a third-party laboratory, product specifications, and safety data sheet submitted, subject article is an ethylene-butene copolymer resin, containing by weight less than 94% ethylene and more than 6% 1-butene, with slip and antiblock additives at concentrations of 1,000 ppm and 5,500 ppm, respectively. It is in the form of a translucent/white solid, with a melt flow index of 1.1 g/10 minutes at 190°C and a density of 0.922 g/cm³. Packed in 25-kg bags, subject article is used in the manufacture of trash can liners, agricultural films, and stretch wraps, and for blending with low density polyethylene (LDPE).

Based on the product composition reported by a third-party laboratory, product specifications, and safety data sheet submitted, subject article is an ethylene-butene copolymer resin, containing by weight less than 94% ethylene and more than 6% 1-butene. It is in the form of a translucent/white solid, with a melt flow index of 2.0 g/10 minutes at 190°C and a density of 0.919 g/cm³. Packed in 25-kg bags, subject article is used in the manufacture of stretch wraps and co-extrusion films, industrial films and bags, heavy duty bags, and trash liners.


