

Subject article is to be used as a complete skin care regimen to soothe, moisturize, energize, rejuvenate, and improve texture.

The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers, among others, other beauty or make-up preparations and preparations for the care of the skin (other than medicaments), such as beauty creams, cold creams, make-up creams, cleansing creams, skin foods (including those containing bees' royal jelly) and skin tonics or body lotions.

4 DESCRIPTION OF GOOD

"DXN GEMPYURI LIFTING IMPACT AMPOULE OIL"

Based on the product ingredient declaration, manufacturing process flowchart, product information sheet, product label, and photograph of actual product submitted, subject article is a facial ampoule oil in the form of a yellow liquid containing argan oil and other skin-conditioning agents. Packed in a 30-mL bottle placed in a box, subject article is applied by patting it on the face, from inward to outward, for over-all skin regeneration and firmness enhancement.

"CATALINA® SCUBA DIVING CYLINDER, MODEL: \$80.001"

Based on the brochure submitted, subject article is a cylindrical container used for holding compressed air. It is made from aluminium alloy 6061-T6 and conforms to ISO 7866 (Refillable seamless aluminium alloy gas cylinders) standard. Threaded at the mouth for valve installation, subject article is intended for use in scuba diving and has the following specifications:

5 REASONS FOR CLASSIFICATION

Heading 76.13 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers aluminium containers for compressed or liquefied gas. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers containers of any capacity used for the transport or storage of compressed or liquefied gases (e.g., helium, oxygen, argon, hydrogen, acetylene, carbon dioxide or butane). These containers may be fitted with control, regulating and measuring devices such as valves, taps, pressure gauges, level indicators, etc.

In view thereof, subject article is classified under AHTN 2017 subheading 7613.00.00, with a Most Favoured Nation (MFN) rate of duty of 7% ad valorem.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.



"DXN GEMPYURI VOLUME ENERGY SERUM"

Based on the product ingredient declaration, manufacturing process flowchart, product information sheet, product label, and photograph of actual product submitted, subject article is a facial serum in the form of a beige liquid. It contains skin-conditioning agents and amethyst and peptide proteins that help revitalize and tighten the skin. Packed in a 50-mL bottle placed in a box, subject article is applied evenly to the face and neck after washing to improve skin elasticity and to soften and smoothen it.
