



#### 4 DESCRIPTION OF GOOD

# "ZER0 PLASTIC WATER-SOLUBLE BAG"

Based on the product information, statement of product composition, photographs of the actual product, utility model patent from the Intellectual Property Office of the Philippines (IPOPHL), and material safety data sheet submitted, subject article is a laundry bag made of polyvinyl alcohol (PVA/PVOH), plasticizer, and organic additive, which can be dissolved in cold, warm, or hot water. It is available in various colors and dimensions (WxL), such as 26" x 34", 28" x 39", and 36" x 39". To be imported in rolls, subject article is used for packing, transporting, and washing of soiled and contaminated fabrics to prevent exposure of handlers from chemicals, pathogens and other biological hazards and to reduce their risk of injury and infection.

#### 5 REASONS FOR CLASSIFICATION

Heading 39.23 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, articles for the conveyance or packing of goods, of plastics. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers all articles of plastics commonly used for the packing or conveyance of all kinds of products. The articles covered include, among others, containers such as boxes, cases, crates, sacks and bags (including cones and refuse sacks), casks, cans, carboys, bottles and flasks.

In view thereof, subject article is classified under AHTN 2017 subheading 3923.29.90, with a Most Favoured Nation (MFN) rate of duty of 15% ad valorem and an ASEAN-China Free Trade Agreement (ACFTA) rate of duty of 5% ad valorem, subject to submission of Certificate of Origin (CO) Form "E".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.



#### 4 DESCRIPTION OF GOOD

#### "DXN M MIRACLE MARINE LIPOSOME CALMING TONER"

Based on the product ingredient declaration, product label, photograph of actual product, and manufacturing process flowchart submitted, subject article is a liquid skin toner containing skin-conditioning agents such as sea water, betaine, xylitol, *Ganoderma lucidum* extract, and *Spirulina platensis* extract, among others. Packed in 150-mL bottles, subject article is to be used as a calming toner which employs liposome technology to help balance the skin and maintain good skin condition.



#### 5 REASONS FOR CLASSIFICATION

Heading 33.04 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, beauty or make-up preparations and preparations for the care of the skin (other than medicaments), including sunscreen or sun tan preparations. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers, among others, other beauty or make-up preparations and preparations for the care of the skin (other than medicaments), such as: face powders (whether or not compressed), baby powders (including talcum powder, not mixed, not perfumed, put up for retail sale), other powders and grease paints; beauty creams, cold creams, make-up creams, cleansing creams, skin foods (including those containing bees' royal jelly) and skin tonics or body lotions.

In view thereof, subject article is classified under AHTN 2017 subheading 3304.99.90, with a Most Favoured Nation (MFN) rate of duty of 7% ad valorem and ASEAN-Korea Free Trade Area (AKFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "AK".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
