#### 4 DESCRIPTION OF GOOD

#### "MECHANISM SUB-ASSY (THERMAL HEAD WITH CPU)"

Based on the technical information submitted, subject article is an assembly consisting of a central processing unit (CPU) sub-assembly [CPU, random-access memory (RAM), motherboard, video graphics array (VGA), High-Definition Multimedia Interface (HDMI), USB, ethernet, and serial ports, among others]; fixed blade sub-assembly; frame side (left and right) sub-assemblies; frame base sub-assembly; and cover roll sub-assembly. It has an overall dimension of 145 mm x 188 mm x 108 mm (WxDxH) and weight of 2.0 kg. Subject article is to be assembled together with the other parts (e.g., main circuit board, panel sub-assembly, frame rear sub-assembly, and main casing which are not part of the importation) to produce a compact point of sale (POS) terminal, with receipt printer, using thermal printing technology (TM-T70II-DT2 model).



#### 5 REASONS FOR CLASSIFICATION

Heading 84.71 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, automatic data processing machines and units thereof. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers, among others, separately presented constituent units of automatic data processing systems. These may be in the form of units having a separate housing or in the form of units not having a separate housing and designed to be inserted into a machine (e.g., insertion onto the main board of a central processing unit).

In view thereof, subject article, being essentially a central processing unit of a compact point of sale terminal, is classified under AHTN 2017 subheading 8471.50.90, with a Most Favoured Nation (MFN) rate of duty of zero and ASEAN-China Free Trade Area (ACFTA) rate of duty of zero, subject to the submission of Certificate of Origin (CO) Form "E".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

#### 4 DESCRIPTION OF GOOD

#### "A/D SEMI GLOSSY BLACK"

Based on the product information and material safety data sheet submitted, subject article is a black liquid paint, consisting of carbon black (as pigment), xylene (as solvent), and kaolin and calcium carbonate (as fillers), among others. To be imported in 16-kg pails, subject article is mixed with acrylic thinner and is used in painting the metal parts of the wheelhouses of automotive vehicles.

#### 5 REASONS FOR CLASSIFICATION

The Harmonized System (HS) General Explanatory Notes to Chapter 32 state that the chapter also includes colouring matter of vegetable, animal or mineral origin and synthetic organic colouring matter and most of the preparations obtained from these colouring matters (paints, ceramic colours, inks, etc.).

Heading 32.10 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers other paints and varnishes (including enamels, lacquers and distempers).

In view thereof, subject article is classified under AHTN 2017 subheading 3210.00.99, with a Most Favoured Nation (MFN) rate of duty of 7% ad valorem and ASEAN Trade in Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

#### 4 DESCRIPTION OF GOOD

#### "STM-40-T1"

Based on the product safety datasheet and ingredients list submitted, subject article is a mixture of petroleum resin, aluminium pigment, organic solvents, and additives, in the form of a silver liquid with characteristic odor. Packed in 15-kg cans, subject article is used as a paint for motorcycle plastic parts.

### 5 REASONS FOR CLASSIFICATION

Heading 32.08 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, paints and varnishes (including enamels and lacquers) based on synthetic polymers or chemically modified natural polymers, dispersed or dissolved in a non-aqueous medium. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that paints of this heading are dispersions of insoluble colouring matter (chiefly mineral or organic pigments, or colour lakes), or metallic flakes or powders, in a vehicle consisting of a binder dispersed or dissolved in a non-aqueous medium. The binder, which is the film-producing agent, consists of synthetic polymers (such as phenolic resins, amino-resins, thermosetting or other acrylic polymers, alkyds and other polyesters, vinyl polymers, silicones, epoxide resins and synthetic rubber) or of chemically modified natural polymers (such as chemical derivatives of cellulose or natural rubber).

In view thereof, subject article is classified under AHTN 2017 subheading 3208.90.90, with a Most Favoured Nation (MFN) rate of duty of 7% ad valorem; and Philippines-Japan Economic Partnership Agreement (PJEPA) and ASEAN-Japan Comprehensive Economic Partnership Agreement (AJCEPA) rates of duty of zero, subject to submission of Certificate of Origin (CO) Forms "JP" and "AJ", respectively.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
