4 DESCRIPTION OF GOOD

"DXN LION'S MANE OOCHA PREMIX TEA"

Based on the product information sheet, manufacturing process flowchart, product ingredient declaration, and photograph of the product submitted, subject article is a tea preparation composed of non-dairy creamer, sugar, Oolong tea powder, and Lion's Mane mushroom powder. It is in the form of a green powder with a silky, pure, and rich taste. Packed in boxes containing twelve (12) 30-g foil packs, subject article is to be dissolved in 200-mL hot or cold water before consumption.



5 REASONS FOR CLASSIFICATION

Heading 21.01 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, extracts, essences and concentrates, of coffee, tea or maté and preparations with a basis of these products or with a basis of coffee, tea or maté. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that the heading covers, among others, preparations with a basis of coffee, tea or maté. These preparations include, *inter alia*, tea preparations consisting of a mixture of tea, milk powder and sugar.

In view thereof, subject article is classified under AHTN 2017 subheading 2101.20.90, with a Most Favoured Nation (MFN) rate of duty of 10% ad valorem and ASEAN-China Free Trade Area (ACFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "E".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
