4 DESCRIPTION OF GOOD

"FAVIPIRAVIR TABLETS (200 mg and 400 mg)"

Based on the prescribing information, material safety data sheet, and photographs of packaging submitted, subject articles are antiviral drugs in the form of film-coated light-yellow tablets containing favipiravir, as active ingredient, and excipients. Favipiravir is a prodrug that is metabolized in cells to the active favipiravir-ribosyl triphosphate form (favipiravir RTP), which selectively inhibits ribonucleic acid (RNA) polymerase involved in viral replication. Packed in boxes containing one blister pack of 34 tablets (200 mg) or 17 tablets (400 mg), subject articles are to be taken orally for the treatment of mild to moderate COVID-19 disease.



5 REASONS FOR CLASSIFICATION

Heading 30.04 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers medicaments (excluding goods of heading 30.02, 30.05 or 30.06) consisting of mixed or unmixed products for therapeutic or prophylactic uses, put up in measured doses (including those in the form of transdermal administration systems) or in forms or packings for retail sale. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers medicaments consisting of mixed or unmixed products, provided they are, among others, put up in measured doses or in forms such as tablets, ampoules, capsules, cachets, drops or pastilles, medicaments in the form of transdermal administration systems, or small quantities of powder, ready for taking as single doses for therapeutic or prophylactic use. The heading applies to such single doses whether in bulk, in packings for retail sale, etc.

In view thereof, subject articles are classified under AHTN 2017 subheading 3004.90.99, with a Most Favoured Nation (MFN) rate of duty of 5% ad valorem and ASEAN-India Free Trade Area (AIFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "AI".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
