Forwarded is the hereto attached letter-reply from Engr. William P. Cuñado, Director, Environmental Management Bureau, Department of Environment and Natural Resources (EMB-DENR) to Mr. David Minol, Home Credit dated October 26, 2021 with IIS Transaction No. CO-2021-039782 inquiring on the requirements for the export of five (5) kilograms of black color tektite stone to the Czech Republic.

Noting that the said materials are personal collections maintained in the said country, EMB-DENR **interposed no objection** to the proposed export without need of Export Clearance subject to the following conditions that:

- a. it shall be limited to the declared type and quantity of material; and
- b. it does not preclude compliance with the requirements of other government agencies having mandates or jurisdiction regulating the same, as well as with the domestic regulation of the country of import.

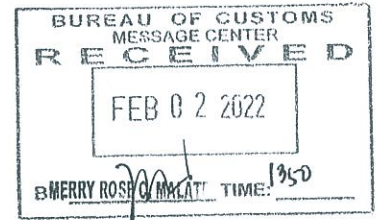
