#### 4 DESCRIPTION OF GOOD

#### "LECIGELTM"

Based on the product composition, manufacturing process flowchart, material safety data sheet, process and origin certificate, product catalogue, and technical specifications submitted, subject article is a white to off-white powder produced by mixing sodium acrylates copolymer and lecithin. Packed in a 20-kg carton with inner polyethylene bag, subject article is used as a gelling agent for aqueous gels; emulsifier for gel-creams; and viscosity adjuster and stabilizer for other cosmetic formulations, with a recommended dosage of 0.1% to 2% depending on the product application.

# 5 REASONS FOR CLASSIFICATION

Heading 38.24 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, chemical products and preparations of the chemical or allied industries (including those consisting of mixtures of natural products), not elsewhere specified or included. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that chemical or other preparations are either mixtures (of which emulsions and dispersions are special forms) or occasionally solutions. Aqueous solutions of the chemical products of Chapter 28 or 29 remain classified within those Chapters, but solutions of these products in solvents other than water are, apart from a few exceptions, excluded therefrom and accordingly fall to be treated as preparations of this heading. The preparations classified here may be either wholly or partly of chemical products (this is generally the case) or wholly of natural constituents.

In view thereof, subject article, is classified under AHTN 2017 subheading 3824.99.99, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
