

4 DESCRIPTION OF GOOD

"EUTHYROX® 100 MCG TABLET (LEVOTHYROXINE SODIUM)"

Based on the certificate of product registration from the Food and Drug Administration (FDA), prescribing information, and photograph of packaging submitted, subject article is a thyroid hormone replacement. It is in the form of tablets containing 100 mcg Levothyroxine sodium (active ingredient) and excipients. Levothyroxine is a synthetic thyroid hormone identical to the natural thyroid hormone thyroxine (T4). It is converted to tri-iodo-thyronine (T3) in the peripheral organs and develops its specific effect at the T3-receptor.

Packed in cartons containing four 25-tablet blister packs, subject article is administered orally for the treatment of benign euthyroid goiter, prophylaxis of relapse after surgery for euthyroid goiter, substitution therapy in hypothyroidism, suppression therapy in thyroid cancer, and diagnostic use for thyroid suppression testing.

5 REASONS FOR CLASSIFICATION

Heading 30.04 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers medicaments (excluding goods of heading 30.02, 30.05 or 30.06) consisting of mixed or unmixed products for therapeutic or prophylactic uses, put up in measured doses (including those in the form of transdermal administration systems) or in forms or packings for retail sale. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers medicaments consisting of mixed or unmixed products, provided they are, among others, put up in measured doses or in forms such as tablets, ampoules (for example, re-distilled water, in ampoules of 1.25 to 10 cm³, for use either for the direct treatment of certain diseases, e.g., alcoholism, diabetic coma or as a solvent for the preparation of injectable medicinal solutions), capsules, cachets, drops or pastilles, medicaments in the form of transdermal administration systems, or small quantities of powder, ready for taking as single doses for therapeutic or prophylactic use.

In view thereof, subject article is classified under AHTN 2017 subheading 3004.39.00, with a Most Favoured Nation (MFN) rate of duty of 1% ad valorem.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
