"ENTELIBRIDGE™ GATEWAY"

Based on the product diagram and brochure submitted, subject article is a communication apparatus designed to integrate one or more building control protocols in a building automation system network. It allows multiple devices positioned across an entire structure to be connected seamlessly within a single network environment for direct monitoring and control. Subject article includes an embedded software which enables the streamlined engineering workflow from initial configuration and engineering to status diagnostic information. It has the following specifications:

5 REASONS FOR CLASSIFICATION

Heading 85.17 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, other apparatus for the transmission or reception of voice, images or other data, including apparatus for communication in a wired or wireless network (such as a local or wide area network), other than transmission or reception apparatus of heading 84.43, 85.25, 85.27, or 85.28. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading includes, among others, other communication apparatus. This group includes apparatus which allows for the connection to a wired or wireless communication network or the transmission or reception of speech or other sounds, images or other data within such a network.

In view thereof, subject article is classified under AHTN 2017 subheading 8517.62.21, with a Most Favoured Nation (MFN) rate of duty of zero and ASEAN-China Free Trade Area (ACFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "E".

4 DESCRIPTION OF GOOD

"BIOPIPE"

Based on the brochure and technical information submitted, subject article is a modularized wastewater treatment system designed to recycle sewage water into clean water based on biofilm bacterial wastewater treatment technology. The system consists essentially of pumps for water circulation, liquid level sensors, valves, control panel, disc cartridge and ultraviolet (UV) filters, polyvinyl chloride (PVC) pipes with synthetic growth media inside (biofilm), activated carbon filter tank, and chlorine tank.

It filters wastewater through the following steps: i) capturing of large inorganic solids in the bar screen chamber; ii) conversion of nutrients in the wastewater into H_2O , CO_2 and N_2 in Biopipe Module 1; iii) reduction of ammonia, nitrogen, and phosphorus in Biopipe Module 2; iv) capturing of inactive bacteria in the disc cartridge filter; v) removal of any remaining suspended solids, ammonia, nitrogen and/or phosphorus in the mixed media filter (MMF) tanks and activated carbon filter (ACF) tanks; vi) elimination of remaining pathogens using a UV filter; and vii) light dosing of treated water with chlorine.

To be imported disassembled, subject article has the capacity to filter wastewater volumes of up to 1000 ${
m m}^3$ /day.

5 REASONS FOR CLASSIFICATION

Heading 84.21 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, filtering or purifying machinery and apparatus for liquids or gases. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading includes among others, filtering and purifying machinery, etc., for liquids, including water softeners. The heading covers not only large industrial plant, but also filters for internal combustion engines and small domestic appliances. The liquid filters of this group separate solid, fatty, colloidal, etc., particles from a liquid, for example, by passing it through a sheet, membrane or mass of porous material. In the treatment of drinking water, some of these materials (e.g., porcelain and charcoal) remove bacteria, etc., in the process of filtration; filters using these materials are therefore sometimes called "water purifiers". The heading covers liquid filters whether of the gravity, suction (or vacuum) or pressure types.

In view thereof, subject article is classified under AHTN 2017 subheading 8421.21.23, with a Most Favoured Nation (MFN) rate of duty of 5% ad valorem and ASEAN-India Free Trade Area (AIFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "AI".

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

4 DESCRIPTION OF GOOD

"ALPHAMALT HCTE"

Based on the product specifications, product information, certificate of analysis, duly certified product composition, material safety and data sheet, and production process submitted, subject article is an enzyme preparation in the form of a beige to brownish powder. It is composed of enzyme concentrate (based on a multi-specific enzyme from non-pathogenic microorganism strain) and wheat flour. Packed in a 25-kg polyethylene bag inside a cardboard box, subject article is added to flour at a dosage of 3 to 4 g per 100 kg of flour, to reduce the firmness and elasticity of the dough and increase its extensibility and fermentation stability.

5 REASONS FOR CLASSIFICATION

Heading 35.07 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, prepared enzymes not elsewhere specified or included. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that enzymes are organic substances produced by living cells; they have the property of causing and regulating specific chemical reactions inside or outside living cells, without themselves undergoing any change in their chemical structure. Enzymes may be referred to according to, among others, their biological activity as amylases, lipases, proteases, etc. This heading includes, among others, prepared enzymes not elsewhere specified or included. Prepared enzymes are obtained by further dilution of enzymatic concentrates or by intermixing isolated enzymes or enzymatic concentrates. Preparations with substances added, which render them suitable for specific purposes, are also included in this heading, provided they are not covered by a more specific heading in the Nomenclature.

In view thereof, subject article is classified under AHTN 2017 subheading 3507.90.00, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem.

4 DESCRIPTION OF GOOD

"AGROCEL'S MAHALAABH POTASSIUM SCHOENITE"

Based on the product composition, certificate of analysis, safety data sheet, manufacturing process description and flowchart, technical data sheet, and product brochure submitted, subject article is a potassium schoenite (K₂SO₄.MgSO₄.6H₂O) in the form of a white crystalline powder. It is produced by the decomposition of kainite (mixed salt from the solar evaporation of seawater), followed by filtration and purification to remove the impurities, then drying and packing. Packed in polypropylene (PP) woven bags containing 10 1-kg trilaminated printed pouches or two 5-kg trilaminated printed bags, subject article is used as a straight fertilizer and in fertigation and foliar applications.

5 REASONS FOR CLASSIFICATION

Heading 31.05 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, goods of this Chapter in tablets or similar forms or in packages of a gross weight not exceeding 10 kg.

In view thereof, subject article is classified under AHTN 2017 subheading 3105.10.90, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem and an ASEAN-India Free Trade Area (AIFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "AI".
