I, ALFREDO L. ALAY-AY, of legal age, Filipino, with postal address at Lot 8 Blk. 104 Robinson Homes East. Brgy. San Jose, Antipolo City, being first duly sworn in accordance with law, hereby depose and state:


- 1. I am the Customs Representative of PONDEROSA LEATHER GOODS CO., INC., an employee of Ponderosa Leather Goods Co., Inc.
- 2. I was assigned by Ms MARILOU N. OMBANIA to process the shipments of Raw Materials and Accessories of Baseball Gloves/Hockey Gloves consigned to PONDEROSA LEATHER GOODS CO., INC., declared under Entry Nos. W338-18 (T89155), W230-18 (T89144), W479-18(T88051) and W847-18(T89181).
- 3. On January 3, 2018, all the original documents of the said import entries with attachments from the Customs Examiner were with me to continue the processing early the following day since I was not able to finished that day.
- 4. On January 4, 2018 at around 4:30 in the morning the time we usually woke up, my wife discovered that our window and front dooe were already opened, so she immediately informed me and we found out that my bag containing original documents of above Entries together with my ID's such as SSS, Voter's, company, BOC access pass, ATM cards, mobile phone and my daugther's laptop which was on top of our dining table were already missing.
- 5. Immediately, I reported to the Security Guards of our subdivision, and to the Antipolo Police Station and to Ponderosa Leather Goods Co., Inc., about the incident, and after the thorough search in our neighborhood, for all intents and purposes the said documents and my other belongings were deemed lost and can no longer be recovered.
- 6. I am executing this affidavit in order to attest to the truth of all the foregoing particularly the circumstances attendant to the loss of the said documents and for the continuous processing of documents to finish up to warehousing and cancellation of bonds and for whatever legal purpose it may serve.
