The subject Bureau of Customs Official Receipt bearing Serial No. 189440350 was discovered as missing last October 1, 2018 while the undersigned was preparing the Daily Statement of Collection for September 29, 2018 when I rendered overtime service as Collecting Officer at the Arrival Area, NAIA Terminal 3.

I did not issue the said BCOR as verified from the list of BCORs issued on said date; it was not also in the booklet of the BCORs bearing Serial No. 189440300 to 189440350, which was issued to me by the Collection Division. All the BCORs bearing the serial numbers in series were all accounted for except for the last copy bearing Serial No. 189440350.

Please find attached herewith the copy of the Daily Statement of Collection for September 29, 2018 and an Affidavit of Loss that I executed to attest the loss of the said document.

AFFIDAVIT OF LOSS

I, BARA LIDASAN III, Collecting Officer, with office address t the Collection Division, NAIA Collection District III, Pasay City, after having been duly sworn in accordance with law, hereby depose and state that:

I am designated as Collecting Officer and presently assigned at the DHL Assessment Composite Division, NAIA Collection District III;

In addition to my regular duties at the DHL Assessment Composite Division, I am also required to render overtime service as Collecting Officer at the Arrival Area of NAIA Terminals 1, 2 and 3 based on our monthly work schedule;

On September 29, 2018, I was on duty as Collecting Officer at NAIA Terminal 3. During my tour of duty, I issued several Bureau of Customs Official Receipts (BCOR) for collection of duties and taxes from taxable articles brought in by arriving passengers;

At the end of my tour of duty, and while preparing the Daily Statement of Collection on October 1, 2018, I discovered that BCOR bearing Serial Number 189440350 was not among the official receipts I issued at that time. I inquired from the Duty Examiner at the Arrival Area to check their list if ever I issued BCOR No. 189440350, but there was none, again I checked the booklet to ascertain if the remaining BCOR was still there but there was none. Attached herewith is the copy of the Daily Statement of Collection for September 29, 2018 for reference;
