CUSTOMS MEMORANDUM CIRCULAR NO. __259 - 2018

Subject: Convention on International Trade in Endangered Species of Fauna and Flora (CITES)/Notifications

Attached is the letter dated 21 November 2018 of Ms. Marlynn M. Mendoza, In-Charge, Office of the Director, Biodiversity Management Bureau (BMB), DENR endorsing copies of CITES' Notifications to the Parties concerning the application of Article XIII ("International measures") of the Convention, as follows:

- No. 2018/081 maintaining the recommendation to suspend trade in African grey parrots (Psittacus erithacus) from the Democratic Republic of Congo (DRC);
- No. 2018/082 recommending to suspend trade in stockpiled specimens of pangolins (Manis spp.) from DRC;
- No.2018/083 recommending to suspend commercial trade in Dalbergia spp. from Lao People's Democratic Republic (PDR), including finished products like carvings and furnitures; and
- **No. 2018/084** recommending to suspend the commercial trade of West African rosewood (*Pterocarpus erinaceus*) from Nigeria.

The BMB-DENR informs that they shall not issue any CITES Permit for the import of any of the aforesaid species from the above-mentioned countries.

Should said shipment be encountered, concerned officers are enjoined to coordinate with the BMB-DENR for confirmation of identification of the species and/or other appropriate/legal measures. The directory of DENR officials in Regions with International Seaports and Airports is also attached.

It is an international agreement between governments which aim is to ensure that international trade in specimens of wild animals and plants does not threaten their survival. Dear Commissioner Lapeña,

We wish to provide you with copies of CITES¹ Notifications to the Parties concerning the application of Article XIII ("International measures") of the Convention, as follows:

No. 2018/081 maintaining the recommendation to suspend trade in African grey parrots (*Psittacus erithacus*) from the Democratic Republic of the Congo (DRC);

No. 2018/082 recommending to suspend trade in stockpiled specimens of pangolins (Manis spp.) from DRC;

No. 2018/083 recommending to suspend commercial trade in *Dalbergia spp*. from LAO People's Democratic Republic (PDR), including finished products like carvings and furniture;

No. 2018/084 recommending to suspend the commercial trade of West African rosewood (Pterocarpus erinaceus) from Nigeria.

In view of said recommendations and as part of our compliance with the CITES, this Bureau - the CITES Management Authority of the Philippines for terrestrial species, shall not issue any CITES Permit for the import of any of the aforesaid species from the above-mentioned countries, hence, any importation thereof shall be considered illegal.

Relative thereto, may we request the assistance of your Office in disseminating the aforesaid notifications and information to concerned BOC office and personnel in all international air and sea ports in the country. In case the BOC personnel encounter shipment of said CITES-listed plants and animals from affected countries into the Philippines, kindly advise them to coordinate with the concerned DENR Regional Office for confirmation of identification of the species, and/or confiscation of items and execution of other appropriate legal measures in accordance with Republic Act 9147 (Wildlife Resources Conservation and Protection Act of 2001) and other relevant laws, if warranted. Please find attached the contact details of the concerned DENR Regionals Offices for your reference.

APPLICATION OF ARTICLE XIII IN THE DEMOCRATIC REPUBLIC OF THE CONGO

Reissue of a recommendation to suspend trade in African grey parrots (Psittacus erithacus)

- Pursuant to Article XIII of the Convention, the Standing Committee at its 70th meeting (SC70, Sochi, October 2018) agreed to maintain the recommendation to suspend trade in specimens of African grey parrot (Psittacus erithacus) from the Democratic Republic of Congo (DRC) pending compliance with the recommendations made at its 69th meeting (SC69). It is recalled that this recommendation was first agreed at its 66th meeting and has been valid since 15 January 2016.
- 2. For ease of reference, it is recalled that the Standing Committee at SC69 (SC69 SR) recommended that:
 - c) a non-Party to the Convention for Psittacus erithacus, in accordance with Resolution Conf.4.25 (Rev. CoP14), the DRC treat the species as if it were included in Appendix II for all purposes, including documentation and control, and suspend the issuance of export permits for commercial and non-commercial trade in specimens of Psittacus erithacus of wild origin until it is in a position to make scientifically based non-detriment findings for trade in the species;
 - d) the DRC take steps to implement CoP Decision 17.256 on African grey parrots (Psittacus erithacus);
 - the DRC not establish experimental export quotas as part of scientific surveys of the species in the country;
 - f) the Standing Committee notes the moratorium announced by the DRC to suspend trade of Psittacus erithacus and its announcement that it will not implement its reservation on the listing of the species in Appendix I and It invites DRC to adopt a regulatory act to implement the moratorium, and
 - g) the Standing Committee also notes the commitment by the DRC to undertake population surveys and develop a management plan for Psittacus erithacus.
- 3. At SC70, the Standing Committee further encouraged donors and cooperation agencies to support DRC in the undertaking of population surveys and development of management plans for *Psittacus erithacus*;
- 4. Parties are reminded that the complete list of Parties subject to a recommendation to suspend trade is available on the CITES website under <u>Documents/Trade suspensions</u>. Parties are requested to implement this recommendation and to inform their enforcement and Customs; authorities of the trade suspension to avoid the inadvertent acceptance of specimens of species subject to such a recommendation.
- The Notification replaces Notification to the Parties No. 2017/063 of 26 September 2017 and Notification 2016/021 of 16 March 2016.

APPLICATION OF ARTICLE XIII IN THE DEMOCRATIC REPUBLIC OF THE CONGO

Recommendation to suspend trade in stockpiled specimens of pangolins (Manis spp.)

 Pursuant to Article XIII of the Convention, the Standing Committee at its 70th meeting (SC70, Sochi, October 2018) adopted a recommendation concerning the Democratic Republic of Congo (DRC) with respect to stockpiled specimens of *Manis* spp. as follows:

Regarding trade in pangolin stockpiles

- Parties shall suspend trade in stockpiled specimens of Manis spp. from DRC, until further guidance is provided by the Conference of the Parties at its 18th meeting (CoP18);
- The Secretarial hereby notifies Parties of the Standing Committee's recommendation to suspend trade in stockpiled specimens of pangolins from the DRC with immediate effect. Parties are requested to inform their enforcement and customs authorities of this recommendation to suspend trade to avoid the inadvertent acceptance of specimens of species subject to such a recommendation.
- For ease of reference, it is recalled that the Standing Committee at SC69 adopted the following recommendation (see SC69 SR):

Given the differing interpretation of Article VII paragraph 2 and Resolution Conf. 13.6 (Rev. CoP16) as they relate to the requirements for trade in specimens, including stockpiles, of Appendix I species that were obtained when the species was listed in Appendix II or Appendix III, the Standing Committee recommends that:

- a) the Secretariat prepare a document for consideration at CoP18, including information relating to the implications associated with the different interpretations; and
 - b) in the interim and until a decision is made by CoP18, Parties should treat specimens, including stockpiles, of Appendix I species of pangolin obtained when the species was listed in Appendix II, as Appendix I specimens and regulate trade in accordance with Article III of the Convention.

APPLICATION OF ARTICLE XIII IN THE LAO PEOPLE'S DEMOCRATIC REPUBLIC

Recommendation to suspend commercial trade in rosewood (Dalbergia spp.)
and other recommendations

- Pursuant to Article XIII of the Convention, the Standing Committee at its 70th meeting (SC70, Sochi, October 2018) adopted a recommendation concerning the Lao People's Democratic Republic (Lao PDR) with respect to the management of exports of *Dalbergia* spp., as follows:
 - a) Parties shall suspend commercial trade in specimens of the genus Dalbergia spp., including finished products, such as carvings and furniture, from the Lao People's Democratic Republic until Lao PDR makes scientifically based non-detriment findings for trade in the relevant species, including D. cochinchinensis and D. oliveri in the country to the satisfaction of the Secretariat.
- 2. The Secretariat hereby notifies Parties of the Standing Committee's recommendation to suspend commercial trade in specimens of *Dalbergia* spp., including finished products such as carvings and furniture from the Lao People's Democratic Republic with immediate effect.
- 3. Parties are requested to inform their enforcement and customs authorities of this recommendation to suspend trade to avoid the inadvertent acceptance of specimens of species subject to such a recommendation. Parties that issue import permits for trade in specimens of Appendix-II species are also encouraged to consult the list when processing applications.
- 4. The Standing Committee, at its 70th meeting, also adopted additional recommendations concerning Lao PDR with respect to: national legislation; CITES Scientific Authorities, enforcement; monitoring of wildlife farms and related trade; and public awareness raising. Lao PDR was requested to report on the implementation of the recommendations to the Secretariat by 1 February 2019 for the Secretariat to convey the report and its recommendations to the next meeting of the Standing Committee (SC71, Colombo, May 2019). - 5. The Standing Committee further invited Parties, CITES Secretariat, international non-governmental organizations and development partners to make efforts to respond to requests for capacity-building and technical support expressed by Lac PDR to implement the recommendations and to coordinate their support to maximize effectiveness and minimize overlap. In response to a request by Lac PDR and within available resources, the Secretariat will support Lac PDR authorities in the implementation of these recommendations, including on the development of non-detriment findings for the relevant species of the genus Dalbergia spp., the development of adequate national legislation, capacity-building of the CITES authorities and development of an information-collection and reporting system that links several government agencies and provincial offices on CITES-related matters.

APPLICATION OF ARTICLE XIII IN NIGERIA

Recommendation to suspend commercial trade in West African rosewood (Pterocarpus erinaceus) and other recommendations

- Pursuant to Article XIII of the Convention, the Standing Committee at its 70th meeting (SC70, Sochi, October 2018) adopted recommendations concerning Nigeria with respect to the management of trade in specimens of West African rosewood (*Pterocarpus erinaceus*), as follows:
 - a) Parties shall suspend commercial trade in specimens of the species Pterocarpus erinaceus from Nigeria until the Party makes scientifically based non-detriment findings for trade in the species in the country to the satisfaction of the Secretariat and the Chair of the Plants Committee.
- 2. The Secretariat hereby notifies Parties of the Standing Committee's recommendation to suspend commercial trade in specimens of *Pterocarpus erinaceus* from Nigeria with immediate effect. Parties are requested to inform their enforcement and customs authorities of this recommendation to suspend trade to avoid the inadvertent acceptance of specimens of species subject to such a recommendation. Parties that issue import permits for trade in specimens of Appendix-II species are also encouraged to consult the list when processing applications.
- 3. The Standing Committee further encouraged all importing Parties to inform the Secretariat about the volumes of timber of *Pterocarpus erinaceus* imported from Nigeria since the entry into force of the Appendix-II listing.
- 4. The Standing Committee also invited the importing Parties to share with the Secretariat the administrative, legislative and enforcement arrangements put in place to ensure that trade in specimens of this species only takes place when Parties are satisfied that it is in line with the requirements of the Convention, including any relevant stricter domestic measure to verify legality and ensure sustainability; and encouraged those Parties to consider inviting the Secretariat to conduct technical missions in order to strengthen cooperation between range States and importing countries and identity further recommendations to ensure that timber trade is conducted in accordance with the Convention.
- 5. Pursuant to Article XIII of the Convention, the Standing Committee finally adopted additional recommendations concerning Nigeria regarding legislation and enforcement; issuance of export permits and information systems; and handling and disposal of seized stockpiles. Nigeria was requested to report on the implementation of the recommendations to the Secretariat by 31 December 2019 for the Secretariat to convey the report and its comments as well as recommended follow-up measures in case of continued non-compliance to the 73rd meeting of the Standing Committee.
