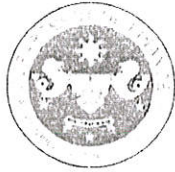

SUBJECT: CONDUCT ON-SITE ASSESSMENT OF THE FACILITIES OF COMPANIES IN THE PREPARATION OF THE MASTER PLAN FOR THE IMPLEMENTATION OF THE FUEL MARKING PROGRAM
