THEREVENUE OFFICE

In the exigency of service, all action documents or papers from the Revenue Office relative to applications or requests for exemptions on importations, regardless of legal basis, shall be approved and signed by Revenue Operations Group (ROG) Undersecretary ANTONETTE C. TIONKO or by Assistant Secretary DAKILA ELTEEN M. NAPAO.

Undersecretary Tionko is further empowered to delegate to the Director IV and/or Director III and/or Officer-in-Charge (OIC) of the Revenue Office the authority to approve and sign such action documents as the Undersecretary may deem appropriate and necessary, subject to the regular submission of a report showing the details of all the documents signed pursuant to said delegated authority every two week.

All are hereby enjoined to strictly observe and follow the foregoing.

This Order revokes Department Order No. 047-2016 dated 16 September 2016 and amends all order and other issuances inconsistent herewith.

Let a copy of this Order be furnished to the Bureau of Customs and the Revenue Office for their proper guidance and strict observance.

This Order shall take effect immediately.
