This is with reference to the Advance Ruling on Tariff Classification (AR) for "Orafti® P95 (Fructo Oligosac Oligofructose) (25 kg)", with TCC (AR) No. 18-411, issued by this Commission on 10 September 2018 to Nestle Philippines, Inc. Said product was classified by this Commission under ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 subheading 1702.60.10 (with 2018 Most Favoured Nation (MFN) rate of duty of 7% ad valorem) based on the production process diagram, technical information (product composition and detailed information about the production facilities and process of Beneo), purchasing specifications (e.g., general description, intended use, composition, sensory requirements), and sample, which you submitted to us during application.

On 09 October 2020, DPO Philippines (DPO) filed an application for AR for Beneo Orafti® P95, the same product as Orafti® P95 (Fructo Oligosac Oligofructose). Based on the more comprehensive submissions of DPO about said product (i.e., brochure, manufacturing process flowchart, product composition, technical analysis of reducing sugar content, chemical characteristics, technical details (form, taste, and odor of the product and clarification on whether the product is a natural sugar), uses, and packaging information), the Commission determined that subject article is 100% oligofructose (CAS No. 308066-66-2), a short chain polymer of fructose, in the form of a white to slightly yellow powder. With said findings, the Commission classified subject article under subheading 3913.90.90, with 2021 MFN rate of duty of 3% ad valorem (see attached TCC (AR) No. 20-197).

Subsection 4.12 of Commission Order No. 2017-01 provides that "In case a Ruling is revoked or modified, the Commission shall give a written notice to the Applicant or issue a public notice setting out the relevant facts and the basis for the revocation or modification". In compliance thereto and in view of the foregoing explanations, this Commission formally informs you that the previously issued TCC (AR) No. 18-411 has been modified by TCC (AR) No. 20-197, issued on 16 March 2021.



4 DESCRIPTION OF GOOD

"BENEO ORAFTI® P95"

Based on the brochure, manufacturing process flowchart, product composition, technical analysis of reducing sugar content, chemical characteristics, technical details, uses, and packaging information submitted, subject article is 100% oligofructose (CAS No. 308066-66-2), a short chain polymer of fructose, in the form of a white to slightly yellow powder. It consists of a mixture of molecules of fructose chains (F_n) and fructose chains with terminal glucose units (GF_n) where "n" ranges from 2 to 8. Subject article is produced by partial enzymatic hydrolysis of raw inulin (extracted from chicory roots), followed by subsequent refining, then spray drying. Packed in 25-kg bags, subject article is a non-digestible carbohydrate that is used as an ingredient in various food applications, such as milk powder, infant and child formula, and bakery products, to improve their nutritional and technological profiles.

5 REASONS FOR CLASSIFICATION

The General Explanatory Notes to Chapter 39 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 state that polymers consist of molecules which are characterised by the repetition of one or more types of monomer units.

Furthermore, Note 6(b) to Chapter 39 states that in headings 39.01 to 39.14, the expression "primary forms" applies only to blocks of irregular shape, lumps, powders (including moulding powders), granules, flakes and similar bulk forms.

Heading 39.13 of the AHTN 2017 covers natural polymers (for example, alginic acid) and modified natural polymers (for example, hardened proteins, chemical derivatives of natural rubber), not elsewhere specified or included, in primary forms. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading also includes isolated amylopectin and isolated amylose obtained by the fractionation of starch.

In view thereof, subject article is classified under AHTN 2017 subheading 3913.90.90, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem.

This ruling modifies TCC (AR) No. 18-411 issued on 10 September 2018.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
