Shipments of Rice

- 1. Attached **"Annex A"** is the reference values of rice covering the period of November 13-19, 2017, as per country of origin.
- 2. All import entries under the tariff headings provided in Annex A, with declared values falling below the reference values shall be released only when the officials of Formal Entry Division have reviewed and ascertained the accuracy of the declared value if it is indeed the true Transaction Value, pursuant to Section 707 of Republic Act No. 10863 (Customs Modernization and Tariff Act). Otherwise, the importer shall nevertheless be able to secure the release of the imported goods upon posting of a sufficient security in an amount equivalent to the duties and taxes in dispute conditioned on the payment of additional duties and taxes, if any, as may be determined.

The importer's right to appeal to the decision of the bureau shall be governed by the provisions of Section 1106 of the same act.

- 3. The reference values indicated in **Annex A**, shall be updated on a weekly basis.
- Non-compliance by any customs official with any provision of this Memorandum will be considered Simple Neglect of Duty pursuant to CMO 25-2010, Title IV, Section 2.
- 5. This Memorandum shall take effect immediately.
