- 1.0 Joint Circular No. 1, s. 2018 (JC No. s. 2018) issued by Department of Budget and Management (DBM), Commission on Audit, and the Civil Service Commission, allows the continuation of services of individuals engaged through of Contract of Service (COS) and job order (JO) in all government offices/agencies.
- 2.0 However, due to the 50% reduction on Budget for "Other Professional Services" allotted to the Bureau for FY 2019, renewal of all current COS in the Bureau is not possible.
- 3.0 As such all groups/ports/offices are directed to conduct a thorough review of persons under contract of service under their respective groups/ports/offices.

 - 5.4 Qualifications (Education, Eligibility, Experience and Training based on CMO
- 6.0 All Contracts shall emanate from the Human Resource Management Division.
- 7.0 For strict information and compliance.

^{***}The Proposed Number of COS per Group/Port shall be divided into respective, services, division and units under each Group/Port respectively.

^{***}All Division Chief, Unit Heads, Service Director, Port Collector shall submit their endorsement to their respective Deputy Commissioner/District Collector for approval/concurrence.

^{***}The propose Number of COS Per Group/Port may decrease or increase depending on the position and payment of the endorsed COS as per CMO _____ - 2019.
