



(1) The Customs Modernization and Tariff Act (CMTA) emphasizes the three (3) main functions of Bureau of Customs namely: revenue collection, trade facilitation and border protection. In relation thereto, to effectively carry out these mandates, an organizational and functional re-alignment should be undertaken by the BOC. Certain offices will either be created, renamed, transferred to another Group or Collection District, or upgraded or downgraded to avoid redundant and overlapping functions. Also, some offices will be abolished or merged for optimal efficiency.
