

#### 4 DESCRIPTION OF GOOD

#### "KITA CONTACT PROBES"

Based on the technical specifications, manufacturer's website, and sample submitted, subject articles are microscopic contact elements to be installed in an integrated circuit (IC) socket that is fixed on the printed circuit board (PCB) of IC testers. Each probe consists of a steel spring, sandwiched between two (2) plungers on both ends, and an outer barrel that keeps the plungers intact. It serves as an electronic path for easy and quick connection of the devices under test (DUT) with the PCB during testing. Subject articles are used in testing quality and/or continuity of PCBs, ICs, and other electronic components that have multiple pin packages, with current of less than 16 amperes.



## 5 REASONS FOR CLASSIFICATION

Heading 90.30 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, oscilloscopes, spectrum analysers and other instruments and apparatus for measuring or checking electrical quantities, excluding meters of heading 90.28. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that subject to the provisions of Notes 1 and 2 to this Chapter, separately presented parts and accessories of instruments or appliances of this heading remain classified here.

Note 2(a) to Chapter 90 states that parts and accessories which are goods included in any of the headings of this Chapter or of Chapter 84, 85 or 91 (other than heading 84.87, 85.48 or 90.33) are in all cases to be classified in their respective headings.

Heading 85.36 of the AHTN 2017 covers, among others, electrical apparatus for switching or protecting electrical circuits, or for making connections to or in electrical circuits (for example, switches, relays, fuses, surge suppressors, plugs, sockets, lampholders and other connectors, junction boxes), for a voltage not exceeding 1,000 volts. The pertinent HS EN state that this heading includes apparatus for making connections to or in electrical circuits. This apparatus is used to connect together the various parts of an electrical circuit. It includes other connectors, terminals, terminal strips, etc. These include small squares of insulating material fitted with electrical connectors (dominoes), terminals which are metal parts intended for the reception of conductors, and small metal parts designed to be fitted on the end of electrical wiring to facilitate electrical connection (spade terminals, crocodile clips, etc.).

#### 4 DESCRIPTION OF GOOD

"VELCON SEPARATOR CARTRIDGES, MODELS: SO-6xxVA(5), SO-6xxV(5), and SO-6xxPV(5)"

Based on the brochure and technical information submitted, subject articles are replacement filter/separator cartridges for petroleum/fuel products. These consist of a 200 mesh stainless steel screen coated on both sides with polytetrafluoroethylene (PTFE) polymer, an aluminum tube, and aluminum and/or glass-filled nylon end caps. The screen is lockseam folded and fastened with an internal aluminum clip. These cartridges incorporate a variable hole inner tube combined with a uniform hole pattern outer tube to maintain a uniform flow in vertical filter/separator. To be installed on stationary filtering equipment, subject articles are used to repel coalesced water drops produced from first stage coalescer cartridges while allowing hydrocarbon fluids to pass through.
