4 DESCRIPTION OF GOOD

"LAMONS® RING TYPE JOINT GASKETS"

Based on the technical specifications and sample submitted, subject articles are forged ring-like forms, made from stainless steel, having two (2) basic types: an oval cross section ring (Style 377) and an octagonal cross section ring (Style 388). These are used as sealing materials for specially grooved flanges with size designations such as Nominal Pipe Size (NPS) of 1 inch to 24 inches and Flange Pressure Class of 150 psi to 5000 psi.

5 REASONS FOR CLASSIFICATION

Heading 73.26 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers other articles of iron or steel. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that the heading includes all iron or steel articles obtained by forging or punching, by cutting or stamping or by other processes such as folding, assembling, welding, turning, milling or perforating other than articles included in the preceding headings of this Chapter or covered by Note 1 to Section XV or included in Chapter 82 or 83 or more specifically covered elsewhere in the Nomenclature.

In view thereof, subject articles are classified under AHTN 2017 subheading 7326.90.99, with a Most Favoured Nation (MFN) rate of duty of 15% ad valorem and ASEAN Trade in Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D".

4 DESCRIPTION OF GOOD

"EYLEA (AFLIBERCEPT)"

Based on the brochure, product insert, product label, manufacturing process, and sample submitted, subject article is an iso-osmotic sterile solution for intravitreal injection in the form of a clear to pale-yellow liquid. It contains 40 mg of aflibercept per ml of solution as active ingredient. Aflibercept is formed from the fusion protein of extracellular domains of human vascular endothelial growth factor (VEGF) receptor and human immunoglobulin class G (IgG1) crystallizable fragment (Fc) domain expressed by Chinese hamster ovary (CHO) cells. Packed in carton boxes containing one (1) filter needle and one (1) type I glass vial with an extractable volume of 100 microliter solution, subject article is intended for the treatment of neovascular (wet) age-related macular degeneration, macular edema secondary to central retinal vein occlusion, macular edema, and myopic choroidal neovascularization.



5 REASONS FOR CLASSIFICATION

Heading 30.02 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, antisera, other blood fractions and immunological products, whether or not modified or obtained by means of biotechnological processes. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers, among others, immunological products, whether or not modified or obtained by means of biotechnological processes. Products used for diagnostic or therapeutic purposes and for immunological tests are to be regarded as falling within this product group. This heading also covers interleukins, interferons (IFN), chemokines and certain tumor necrosis factors (TNF), growth factors (GF), hematopoietins and colony stimulating factors (CSF).

In view thereof, subject article is classified under AHTN 2017 subheading 3002.15.00, with a Most Favoured Nation (MFN) rate of duty of 1% ad valorem.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

Based on the ingredient statement, packaging information, production process flowchart, safety data sheet, technical data sheet, and certificate of analysis submitted, subject article is a white to cream powder consisting of sucralose, maltodextrin, synthetic flavouring substances, and natural flavouring substances, among others. It is to be used as flavouring in the manufacture of beverages. Subject article is packed in a 22.68-kg bags and placed in a carton box as secondary packaging.

5 REASONS FOR CLASSIFICATION

Heading 21.06 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers food preparations not elsewhere specified or included. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that provided that they are not covered by any other heading of the Nomenclature, this heading covers, among others, preparations consisting wholly or partly of foodstuffs, used in the making of beverages or food preparations for human consumption.

The Supplementary Explanatory Notes (SEN) to AHTN 2017 subheading 2106.90.98 state that flavouring preparations are mixtures of a single or several flavouring substances or extracts with starch, flour or other food substances acting as a carrier. They are premixed for ease of application to food or beverages and function primarily to impart a characteristic taste.

In view thereof, subject article is classified under AHTN 2017 subheading 2106.90.98, with a Most Favoured Nation (MFN) rate of duty of 1% ad valorem.

This ruling shall be valid for five (5) years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.



Heading 84.18 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers, among others, refrigerators, freezers and other refrigerating or freezing equipment, electric or other. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that the refrigerators and refrigerating equipment of this heading are in the main machines or assemblies of apparatus for the production, in a continuous cycle of operations, of low temperatures (in the region of 0 °C or less) at the active cooling element, by the absorption of the latent heat of evaporation of liquefied gases (e.g., ammonia, halogenated hydrocarbons), of volatile liquids or, in the case of certain marine types, of water.

Heading 87.04 of the AHTN 2017 covers motor vehicles for the transport of goods. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers in particular, among others, ordinary lorries (trucks) and vans (flat, tarpaulin-covered, closed, etc.); delivery trucks and vans of all kinds.

In view thereof, subject article is classified under AHTN 2017 subheading 8704.21.29, with a Most Favoured Nation (MFN) rate of duty of 30% ad valorem and ASEAN-China Free Trade Area (ACFTA) rate of duty of 5% ad valorem, subject to submission of Certificate of Origin (CO) Form "E".

Based on the technical specifications and sample submitted, subject article is a capacitance-based sensor that detects changes in air pressure to determine the level of water inside a washing machine. Rated at 5V DC, subject article is composed of a coil and capacitor (enclosed in polypropylene material) that will send electrical signals into the washing machine's circuit for the control of water flowing from the water inlet.



5 REASONS FOR CLASSIFICATION

Heading 90.26 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers instruments and apparatus for measuring or checking the flow, level, pressure or other variables of liquids or gases (for example, flowmeters, level gauges, manometers, heat meters), excluding instruments and apparatus of heading 90.14, 90.15, 90.28 or 90.32. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers instruments and apparatus for measuring or checking the flow, level, pressure, kinetic energy or other process variables of liquids or gases. Measuring or checking apparatus generally incorporates an element sensitive to variations in the quantity to be measured (e.g., Bourdon tube, diaphragm, bellows, semiconductors) moving a needle or a pointer. In some devices the variations are converted into electrical signals.

In view thereof, subject article is classified under AHTN 2017 subheading 9026.20.30, with a Most Favoured Nation (MFN) rate of duty of zero and ASEAN Trade in Goods Agreement (ATIGA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "D".

"BOON EDAM® LIFELINE SPEEDLANE SWING"

Based on the technical information submitted, subject article is an electro-mechanical turnstile with swinging glass barriers. It is designed to secure entry/exit in buildings and establishments through its built-in motion sensors and access card readers which can both activate the glass barrier (for authorized access) or the sound alarm (for unauthorized access). Equipped with light-emitting diode (LED) display to guide and give feedback signals to its users, subject article can grant passage for 20-30 people per minute with a standard passageway of 615 mm and glass heights ranging from 940 mm to 1800 mm.



REASONS FOR CLASSIFICATION

Heading 84.79 of the ASEAN Harmonized Tariff Nomenclature (AHTN) 2017 covers machines and mechanical appliances having individual functions, not specified or included elsewhere in this Chapter. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading is restricted to machinery having individual functions, which (a) is not excluded from this Chapter by the operation of any Section or Chapter Note; and (b) is not covered more specifically by a heading in any other Chapter of the Nomenclature; and (c) cannot be classified in any other particular heading of this Chapter since: (i) no other heading covers it by reference to its method of functioning, description or type; and (ii) no other heading covers it by reference to its use or to the industry in which it is employed; or (iii) it could fall equally well into two (or more) other such headings (general purpose machines).



Based on the product specifications, technical and safety data sheets, and sample submitted, subject article is a low cement refractory castable composed of chamotte, calcium aluminate cement, silica, and calcined alumina, among others. It is in the form of pale powder with a maximum grain size of 8 mm and a maximum service temperature of 1,550°C. It is used for a wide variety of industrial applications requiring high-temperature and chemical resistance, such as linings of industrial furnaces. Packed in 25-kg and bulk bags, subject article is to be mixed with water at a rate of approximately 1.5 to 2.0 liters of water (6.0-8.0%) per 25 kilograms of product and is installed by vibration casting with a casting weight requirement of 2.2 tons per cubic meter.



Based on the product specifications, technical and safety data sheets, and sample submitted, subject article is a high alumina refractory castable made from bauxite and calcium aluminate cement, among others. It consists of 69.1% alumina and 14.8% silica, among others, and comes in the form of dark-gray powder with a maximum grain size of 8 mm and a maximum service temperature of 1,500°C. It is used for a wide variety of industrial applications requiring high-temperature and chemical resistance, such as linings of industrial furnaces. Packed in 25-kg and bulk bags, subject article is to be mixed with water at a rate of approximately 2.0 to 2.75 liters of water (8.0-11.0%) per 25 kilograms of product and is installed by vibration casting with a casting weight requirement of 2.5 tons per cubic meter.
