In line with the Memorandum of Agreement between the Bureau of Customs, Department of Energy and the Bureau of Internal Revenue on Information Exchange and Reconciliation and to enhance proper monitoring and verification of fuel products marked under the Fuel Marking Program pursuant to Customs Memorandum Order (CMO) 43-2019, all FMOSS Marking Personnel are requested to disseminate to all stakeholders concerned the herein revised **Request for Marking Form**<sup>1</sup> (Annex A). Further, all FMOSS Marking Personnel shall accomplish the herein **Actual Marking Report Form** (Annex B) for every marking operation conducted.

Please be guided by the following instructions in accomplishing the revised Request for Marking Form and Actual Marking Report Form:

## A. Request for Marking Form

- Request for Marking Form should be completely filled-out by the requesting party and submitted to the FMOSS and Fuel Marking Provider at least two (2) calendar days prior to marking or eight (8) hours prior to operation if using Automatic Injection System;
- Every Request for Marking Form should only be covered by one (1)
  Goods Declaration and its corresponding Import Entry Reference
  Number. If a marking activity is covered by multiple goods
  declaration, separate request for marking forms should be
  submitted.
- Upon receipt of the request, the FMOSS shall ensure completeness of information provided and indicate the Import Entry Reference Number in the "Request for Marking Reference Number" field of the form.

- 4. If at the time of the request, importation details are not yet available, the request may be accepted, provided that importation details should be provided at least eight (8) hours prior to the actual marking schedule, otherwise, marking SHALL NOT BE ALLOWED;
- The FMOSS shall ensure that the total volume requested to be marked is LESS THAN OR EQUAL TO the volume from which the Fuel Marking Fee was based.

To illustrate, please see table below:

- 6. If the volume requested to be marked is higher than the volume from which the Fuel Marking Fee was based, written explanation on the variance and/or evidence of additional payment of duties, taxes and Fuel Marking Fee should be presented by the importer to the FMOSS before marking.
- 7. In case of truck marking, the FMOSS shall monitor and keep record of the following:
  - i. Import Entry Reference Number used for every marking request;
  - ii. Inventory of remaining volume marked or dispensed; and
  - iii. Inventory of remaining volume to be marked if the volume declared in the Goods Declaration is not yet fully marked.

## **B. Actual Marking Report Form**

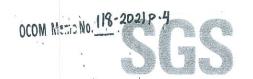
1. To ensure that the marking operations were carried out pursuant to existing guidelines and Standard Operating Procedures (SOPs), the

Actual Marking Report Form shall be accomplished by the FMOSS Marking Personnel during marker preparation and after marking operation, as applicable;

- 2. In coordination with the Fuel Marking Provider, the FMOSS shall request the following documents from the importer or terminal to verify actual volume of fuel discharged:
  - i. Shore Tank Measurement Report Before and After Discharge
  - ii. Ship Figures Before Discharge
  - iii. Ship Figures After Loading
  - iv. Surveyor's Report
- Once completed, the FMOSS Marking Personnel witnessing the activity shall sign the report together with the Fuel Marking Provider. The Fuel Marking Provider may be provided a copy of said report as basis for billing preparation.
- The report shall form part of the report submitted to the FMP-PIO after every marking and weekly report submitted to though the every Thursday.
- For ease of reference, the FMOSS shall ensure that the Fuel Marking Provider indicates in the "Remarks" portion of the Certificate of Marking the Import Reference Number provided by the FMOSS.

## C. Homogeneity Testing

- To ensure that only homogenous fuels are released from the terminal, FMOSS Marking Personnel shall ensure that the agreed method of doping is implemented and shall witness the sampling of shore tanks, vessels, or truck after the six (6) hour settling time recommended by the Fuel Marking Provider, as applicable.
- 2. The Fuel Marking Provider shall ensure the timely testing of the samples and notification of the result thereof to the oil company/terminal, FMOSS and FMP-PIO via e-mail.
- 3. The FMOSS shall not allow withdrawal of fuel if the result of the test is non-homogenous.
- 4. Attached herein as **Annex C** is the Fuel Marking Process Flow, for reference.

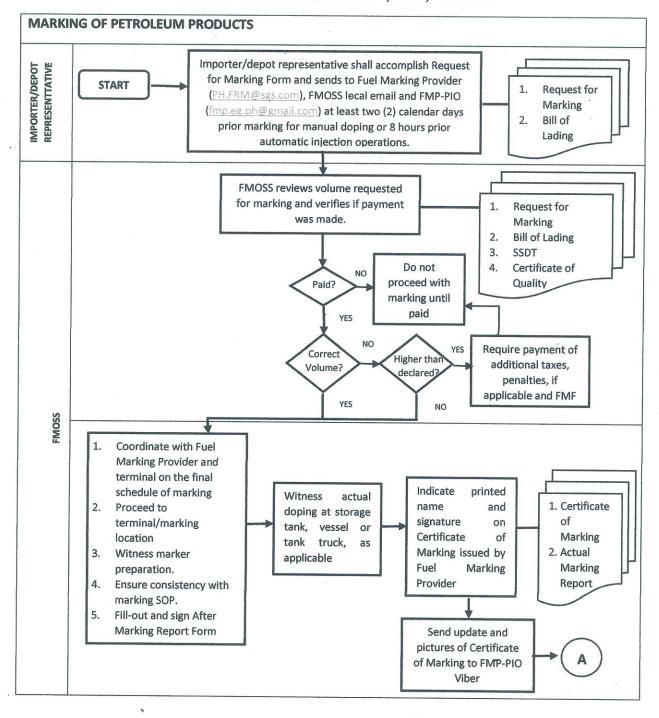

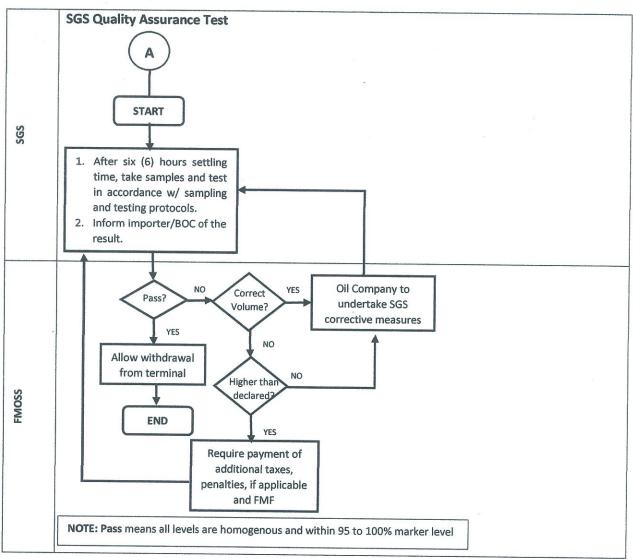
