

The WCO PICARD Conference is an international platform to foster dialogue between the Customs administrations, academic communities and private sector. The Conference is pleased to **call for papers** as follows.

The Conference welcomes any subject of research that is related to the policy, operation and administration of Customs authorities. This includes core missions of Customs such as revenue collection, fraud detection, anti-smuggling, security of borders and trade facilitation, and emerging trends such as data analytics, disruptive technologies, the circular economy and fragile borders.

The Conference also welcomes and encourages submissions from Customs officials, as well as researchers from various academic disciplines, such as anthropology, criminology, economics, geography, history, international relations and international trade, law, mathematics and political science.

Registration for the Conference

Submission process

Two tracks for submission are offered, one for academics and one for Customs experts.

Submissions by Customs experts

Applicants may submit proposals (maximum 500 words) no later than 31 May 2022. The proposal should include the motivation for and objective of the research, the data sets and methodologies to be used, and possible outcomes. The PICARD Scientific Board Members will select the successful proposals and notify the applicants by 15 June 2022.

The selected applicants will draft their research paper under the supervision of a Member or Members of the Scientific Board. The selected applicants are entitled to participation in the week long online course in the second half of July 2022 provided by Victoria University in Canada, with a tuition waiver supported by CCF Korea. The selected applicants who wish to participate the course shall register for the course by 30 June 2022 (https://www.uvic.ca/humanities/intd/europe/travel-and-learn/summer/index.php).

The selected applicants must complete their paper by 15 October 2022.













Submissions by academics

Applicants may submit proposals (maximum 500 words) no later than 30 June 2022. The proposal should include the motivation for and objective of the research, the data sets and methodologies to be used, and possible outcomes. The PICARD Scientific Board Members will select the successful proposals and notify the applicants by 20 July 2022.

The selected applicants must complete their paper by 15 October 2022.

- Name, title, and biography (maximum 250 words) of researcher or researchers.
- Current position, organization, and country of researcher or researchers.

- Arial font size 11.
- Submissions should be in English or French.

Dear Director General/Commissioner,

During the 42nd Session of the World Customs Organization's (WCO) Enforcement Committee, held from 28 March to 1 April 2022, a proposal for the implementation of **Operation THUNDER 2022** was endorsed. Co-led by the WCO and INTERPOL, the Operation will unite Customs and police efforts, along with relevant partners, to clamp down on illegal wildlife and timber trade.

Operation THUNDER 2022 is the sixth edition of the very successful "Thunder" operation series, following Operation THUNDER 2021 conducted in October 2021 with 118 countries participating. During Operation THUNDER 2021, over 1,002 seizures were made and 300 offenders were apprehended.

Members present at the 42nd Session of the WCO Enforcement Committee overwhelmingly supported the proposed continuation of the Operation THUNDER enforcement concept, and endorsed the proposal to implement Operation THUNDER 2022 in the context of increased sustainability and environmental protection. Furthermore, the WCO is dedicating 2022 to scaling up Customs digital transformation by enhancing its data culture. Operation THUNDER 2022 provides Customs administration the opportunity to record quality data on illegal wildlife trade, which in turn will enable Administrations to enhance risk profiles and refine their policies.

The WCO Environment Programme and INTERPOL's Environmental Security Programme will co-lead the global enforcement Operation THUNDER 2022. The key dates for this important initiative are:

- Pre-operational phase from 1 July to 2 October 2022;
- Operational phase from 3 to 30 October 2022; and
- Post-operational phase from 31 October to 31 December 2022.

Please treat these dates as confidential.

A series of trainings will be conducted during the pre-operational phase. The WCO Secretariat is closely monitoring further developments of the global COVID-19 pandemic crisis. Should the pandemic possibly impact the proper implementation of Operation THUNDER 2022 activities, the Secretariat will review the respective dates in the implementation plan, and inform participating Members accordingly.

An Operational Control Center (OCC) will be established for the duration of the Operation.

Your Administration is invited to participate in Operation THUNDER 2022. Should your Administration wish to participate, please nominate two National Contact Points

Please confirm your Administration's participation and send back the NCP Nomination Forms to Ms. Tiffany Lormeau (tiffany.lormeau@wcoomd.org) by **15 May** 2022 at the latest. Please note that only participating Administrations will receive the Operation THUNDER 2022 Operational Plan.

The National Contact Point is responsible, amongst others, to ensure that preoperational risk profiling is conducted, that operational teams are briefed and directed, and that seizure and other relevant operational data is exchanged with the OCC. Based on the experience of previous "Thunder" operations, we would like to kindly impress on participating Members that designated NCPs should be duly mandated to perform the essential functions required from an NCP.

Lastly, it bears mention that the operational phase for Operation Thunder 2022 will run concurrently with the WCO Operation Demeter VII on the illegal transboundary movements of dangerous waste as well as ozone depleting gases and other gases, in an attempt to better coordinate environmental enforcement operations and avoid unnecessary demands on resources. A separate letter of invitation will be sent out in this regard.

I am confident that I can rely on your support for this Operation and can assure you that your involvement will be critical in achieving a successful outcome.

I have the honour to inform you that the WCO has released both **Online** demonstration module and Advanced Data Analytics Course for HS Code Recommendation. The courses are now available in English and French on CLiKC! as of 25 April 2022 with the Customs Cooperation Fund of Korea (CCF-Korea) support.

The Al HS module is created to provide a virtual experience on how Al could assist goods classifications for Customs administrations (http://49.50.165.5:19090).

The module offers a demonstration on what functions the AI HS algorithm, the newly developed analytic model for HS code predictions, presents (http://www.wcoomd.org/en/media/newsroom/2022/march/wco-bacuda-experts-develop-a-neural-network-model-to-assist-classification-of-goods-in-hs.aspx).

Upon entering commercial descriptions into the AI module's search bar, the corresponding HS codes with their probabilities are given. You can check the recommendations, the corresponding standard goods descriptions in the HS Nomenclature, the visualization of the search result in two/three dimensions and key statistics on importers, Customs agents and exporting countries.

The advanced e-learning course has been developed as a succeeding edition of the online beginner, intermediate courses uploaded on CLiKC! in 2021. The advanced course consists of four chapters that holistically guide the user through all requirements and steps to learn theoretical aspects, train, and evaluate the AI HS algorithm based on Customs data voluntarily provided by the Nigerian Customs Service. You can download the model's source code and experience the referral service firsthand through the online course uploaded to the CLiKC! platform.
