Weekly Report to PIAD

Brief Narrative (February 10-14, 2020)

For the period *February 10-14, 2020*, Bureau of Customs, Port of Legazpi, had recorded a total of three (3) entries, one (1) filed formal entry and two (2) completed export entry.

The total duties and taxes collected amounted to **Php30,957,100.00** for February 1-14, 2020.

On February 12, 2020, the Bureau of Customs (BOC) - Port of Legazpi, in coordination with the Philippine Drug Enforcement Agency (PDEA) V, conducted a random physical inspection on rice importation unloaded at the Sub-port of Tabaco in Legazpi City.
