

Contract Agreement Form

THIS AGREEMENT made on the __ of __ between the Bureau of Customs (hereinafter called "the Procuring Entity") of the one part and Nuctech Company Limited of the Beijing, People's Republic of China (hereinafter called "the Supplier") of the other part:

WHEREAS the Procuring Entity invited Bids for certain goods and ancillary services, viz., provision of maintenance service package for twenty eight (28) container x-ray machines installed in selected ports for the period of six (6) months from January 1 to June 30, in 2013 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Hundred Twenty, Million Five Hundred Ninety Eight Thousand Six Hundred Fifty Six Philippine Peso And 75/100 Only (PhP 120,598,656.75), inclusive of applicable Taxes, (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS POLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Scope of Contract (Schedule A) together with Forms A-1, A-2, A-3 and Maintenance Outline Package;
 - (b) the Contract Price and Payment (Schedule B) or Price Quotation;
 - (c) the General Conditions of Contract;
 - (d) the Special Conditions of Contract;
 - (e) the Proof or Certificate of Exclusivity; and
 - (f) the Entity's Notification of Award.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- 4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the
