4 DESCRIPTION OF GOOD

"ZAMIVET80 (ENRAMYCIN)"

Based on the unit dose and formulation, safety data sheet, product specifications, Certificate of Product Registration from the Bureau of Animal Industry (BAI), product label, and packaging submitted, subject article is an anticoccidial medicament consisting of 80g/kg enramycin as active ingredient, with rice hull powder as carrier. It is in the form of a gray to gray-brown powder. Packed in 25-kg bags, subject article is to be premixed with 10-20 kg of feeds then thoroughly mixed with the bulk feed, to obtain a concentration of 5-24 mg enramycin per kilogram of feed. It is indicated for the prevention and treatment of Necrotic enteritis in broilers and layers caused by *Clostridium perfringens*, and of Clostridial enteritis and dysentery in swine.



5 REASONS FOR CLASSIFICATION

Heading 30.03 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers medicaments (excluding goods of heading 30.02, 30.05 or 30.06) consisting of two or more constituents which have been mixed together for therapeutic or prophylactic uses, not put up in measured doses or in forms or packings for retail sale. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers medicinal preparations for use in the internal or external treatment or prevention of human or animal ailments. These preparations are obtained by mixing together two or more substances. The heading includes, among others, preparations containing a single pharmaceutical substance together with an excipient, sweetening agent, agglomerating agent, support, etc.

In view thereof, subject article is classified under AHTN 2022 subheading 3003.20.00, with a Most Favoured Nation (MFN) rate of duty of 3% ad valorem and ASEAN-China Free Trade Area (ACFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "E".

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.

4 DESCRIPTION OF GOOD

"NIELSEN GEN2 BEACON, MODEL: DA114"

Based on the brochure, technical information, and Type Acceptance Certificate from the National Telecommunications Commission (NTC) submitted, subject article is a small device plugged directly into a standard electrical outlet in a household. It emits a Bluetooth[®] signal detectable by the Nielsen DA120 PPM 360^{TM} Meter (imported separately), a portable people meter (PPM) used in collecting data for television rating purposes. It is used to determine whether a particular panelist (person wearing the PPM) is at home or outside. Subject article has the following specifications:

5 REASONS FOR CLASSIFICATION

Heading 85.17 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers, among others, other apparatus for the transmission or reception of voice, images or other data, including apparatus for communication in a wired or wireless network (such as a local or wide area network), other than transmission or reception apparatus of heading 84.43, 85.25, 85.27 or 85.28. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers apparatus for the transmission or reception of speech or other sounds, images or other data between two points by variation of an electric current or optical wave flowing in a wired network or by electro-magnetic waves in a wireless network. The signal may be analogue or digital. The networks, which may be interconnected, include telephony, telegraphy, radio-telephony, radio-telegraphy, local and wide area networks.

"NIELSEN PPM 360™ CHARGING CRADLE, MODEL: DA119"

Based on the brochure submitted, subject article is a charging set consisting of a cradle and a 5 V power supply unit with a Universal Serial Bus (USB) connector. It is used for charging a portable person meter (PPM), specifically the "Nielsen DA120 PPM 360^{TM} Meter" (imported separately). Subject article has voltage and current ratings of 5.0 V and 0.5 A, respectively.



5 REASONS FOR CLASSIFICATION

Heading 85.04 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers electrical transformers, static converters (for example, rectifiers) and inductors. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that electrical static converters are used to convert electrical energy in order to adapt it for further use. This group includes, among others, rectifiers by which alternating current (single or polyphase) is converted to direct current, generally accompanied by a voltage change.

In view thereof, subject article is classified under AHTN 2022 subheading 8504.40.30, with a Most Favoured Nation (MFN) rate of duty of zero.

4 DESCRIPTION OF GOOD

"NIELSEN GTAM NANO PVT2 (RCA LINE AUDIO CABLE)"

Based on the brochure submitted, subject article is an assembly consisting of an insulated cable fitted with an RCA (Radio Corporation of America) male and female connector on one end and a straight tip (ST) interface connector on the other end. It is part of a system that measures audience television (TV) viewing and is specifically used to connect the GTAM (Global Television Audience Metering) Nano PVT 2 Meter (imported separately) to the audio line of a television set. Subject article helps the GTAM Nano PVT 2 Meter detect the audio signal coming from the TV set.



5 REASONS FOR CLASSIFICATION

Heading 85.44 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers, among others, insulated (including enamelled or anodised) wire, cable (including co-axial cable) and other insulated electric conductors, whether or not fitted with connectors. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that provided they are insulated, this heading covers electric wire, cable and other conductors (e.g., braids, strip, bars) used as conductors in electrical machinery, apparatus or installations. Subject to this condition, the heading includes wiring for interior work or for exterior use (e.g., underground, submarine or aerial wires or cables). These goods vary from very fine insulated wire to thick cables of more complex types. Wire, cable, etc., remain classified in this heading if cut to length or fitted with connectors (e.g., plugs, sockets, lugs, jacks, sleeves or terminals) at one or both ends.



"SIPLAN CORTAVIENTOS"

Based on the brochure and technical specifications submitted, subject article is a sunblind designed to complement flat awning systems. It mainly consists of an acrylic fabric, iron rolling tubes, profiles and assembling accessories of aluminium material, polyvinyl chloride (PVC) plastic caps, iron screws, and nylon valve holders. Subject article provides enclosure of the space and is used for protection against the sun and wind. It is to be imported already assembled.

5 REASONS FOR CLASSIFICATION

Heading 63.06 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 cover, among others, tarpaulins, awnings and sunblinds. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading covers a range of textile articles usually made from strong, close woven canvas, among others, awnings, sunblinds (for shops, cafés, etc.). These are designed for protection against the sun; they are generally made of strong plain or striped canvas, and may be mounted on roller or folding mechanisms. They remain classified in this heading even when provided with frames, as is sometimes the case with sunblinds.

In view thereof, subject article is classified under AHTN 2022 subheading 6306.12.00, with a Most Favoured Nation (MFN) rate of duty of 15% ad valorem.

"HUCOG® - 5,000 HP (CHORIONIC GONADOTROPIN)"

Based on the pack insert, Certificate of Product Registration from the Food and Drug Administration (FDA), and photographs of the product submitted, subject article is a sterile lyophilized powder consisting of human chorionic gonadotropin (HuCoG® HP), with an activity of 5000 IU, and excipients. It is a highly purified hormonal preparation derived from the urine of pregnant females and is indicated for the treatment of anovulatory infertility not due to ovarian failure, and of hypogonadotropic hypogonadism, cryptorchism, and delayed puberty associated with insufficient gonadotrophic pituitary function in males. Packed in a carton box containing 2-mL Type 1 glass vial and 1-mL ampoule diluent, subject article is to be reconstituted with the supplied sodium chloride solution for subcutaneous or intramuscular injection at a dosage depending on the frequency of administration.


