For positions not involving practice of profession: COPY of AUTHENTICATED Certificate of Eligibility with Copy of Official Receipt, preferably issued by the CSC Central Office, or COPY of AUTHENTICATED of Valid Professional License or Certificate of Registration or Report of Rating issued by the Professional Regulations Commission or Supreme Court; or
