**SUBJECT: Regulated Brand New/Used Replacement Motor Vehicle Parts
under Central Bank (CB) Circular No. 1389**

Attached is the letter dated 11 February 2014 of Atty. Luis M. Catibayan, Director, Bureau of Import Services (BIS), Department of Trade and Industry (DTI), forwarding to this Bureau a copy of the list of the regulated brand new/used replacement parts of motor vehicles under CB Circular No. 1389.

All importers of said regulated parts are required to secure import clearance from BIS-DTI before their shipment arrives in the country. In addition to other import documents that may be required by this Bureau, importers are required to submit a Certificate of Authority to Import issued by BIS before said importations are released from the BOC.

For your information, guidance and strict implementation.

Please confirm the dissemination of this circular throughout your offices within fifteen (15) days from receipt hereof.

Subject: Regulated Brand New/Used Replacement Motor Vehicle Parts under Central Bank (CB) Circular 1389

Dear Commissioner Sevilla:

We received information that there are regulated motor vehicle parts being imported without the necessary import permit. Please be informed that certain motor vehicle parts are regulated under CB Circular 1389, as amended. As such, all importers of said regulated parts are required to secure import clearance from our office before their shipment arrives in the country. We have attached hereto the list of the remaining regulated motor vehicle parts under CB Circular 1389.

In this connection, we are requesting that a Customs Memorandum Order (CMO) be issued requiring importers of regulated motor vehicle parts to submit, in addition to other import documents that may be required by the BOC, a Certificate of Authority to Import issued by the Bureau of Import Services before said importation are released from the BOC.

Thank you for your cooperation on matters of mutual concern.
