SUBJECT: UNODC Note NAR/CL.5/2014 (A) 1988C-Art.12, CU2014/81 (A)/DTA/SGB dated 03 April 2014.

In view of the attached letter from United Nations Office on Drugs and Crime (UNODC) with the above-stated subject and in relation to the notification from the Government of New Zealand, stating that the provisions of Article 12, par. The Secretary-General of the United Nations presents his compliments to the Secretary for Foreign Affairs of the Republic of the Philippines and has the honour to inform the Government that he has received a notification from the Government of New Zealand pursuant to article 12, paragraph 10(a) and article 24 of the United Nations Convention against Illicit Traffic in Narcotic Drugs and Psychotropic Substances, 1988.

Article 12, paragraph 10(a), of the Convention reads:

"In addition to the provisions of paragraph 9, and upon request to the Secretary-General by the interested Party, each Party from whose territory a substance in Table I is to be exported shall ensure that, prior to such export, the following information is supplied by its competent authorities to the competent authorities of the importing country:

- (i) Name and address of the exporter and importer and, when available, the consignee;
- (ii) Name of the substance in Table I;
- (iii) Quantity of the substance to be exported;
- (iv) Expected point of entry and expected date of dispatch;
- (v) Any other information which is mutually agreed upon by the Parties.
- (b) A Party may adopt more strict or severe measures of control than those provided by this paragraph if, in its opinion, such measures are desirable or necessary."

Article 24 reads:

"A Party may adopt more strict or severe measures than those provided by this Convention if, in its opinion, such measures are desirable or necessary for the prevention or suppression of illicit traffic."

His Excellency Mr. Albert F. del Rosario Secretary for Foreign Affairs of the Republic of the Philippines The Government of New Zealand has informed the Secretary-General that the provisions of article 12, paragraph 10(a), of the 1988 Convention should apply to all substances listed in the revised Table I of the 1988 Convention. The Government of New Zealand has also requested the Secretary-General to inform all Governments that those provisions should also be extended to all substances listed in the revised Table II of that Convention.

The Government of New Zealand has indicated that the following competent authority should be notified in advance of any exportation to its territory of all substances listed in the revised Table I and Table II of the 1988 Convention:
