## CUSTOMS MEMORANDUM CIRCULAR No. 72 - 2017

To: All Collectors of Customs Importers, Customs Brokers, Brokers' Representatives and All Others Concerned

In line with Customs Memorandum Order No. 15 - 2016, the Exchange Rate below duly issued by the Bangko Sentral ng Pilipinas on 24 May, 2017 shall be the applicable Rate of Exchange for the week May 25, 2017 – May 31, 2017 for both the regular consumption entries (formal and informal), warehouse entries as well as withdrawal entries for shipments entered under warehousing.
