Importation Under Letter of Instruction No. 427 and its Implementing Department Order No. 30-76.

In order to expedite the clearance of articles imported or brought to the Philippines for purposes of display or exhibition at the Philippine Center for International Trade and Exhibition (PHILCITE) during an International Fair, Expesition or similar undertaking being held thereat, as well as to protect the interest of the government, Department Order No. 30-76 shall be strictly observed and the Transfer of the said articles to PHILCITE shall be covered by a Permit to Transfer per format shown in Annex A hereof.

This Order shall take effect immediately.
